tion shall have been made to the secretary of state and the registration fee paid. Any person who shall operate any such vehicle upon any highway after May first in the year 1931 or in any other year after March fifteenth, unless the same shall have been registered, or application made, as hereinbefore provided, may be arrested by any sheriff, deputy sheriff, city or village marshal, constable, or any other police officer, and brought before any judge of a court of record or justice of the peace. Such judge or justice shall in addition to imposing the penalty provided by section 85.91 require such person to make application for registration and pay the fee therefor, and two dollars in addition thereto. Such judge or justice shall forthwith forward such application and the fee to the secretary of state, and pay the two dollars collected in addition to the registration fee, to the informant. The absence of number plates shall be prima facie evidence that the vehicle is not registered. The provisions of this subsection shall not apply to any motor vehicle while being taken over the public highway by any dealer or distributor, in compliance with subsection (5) of section 85.02, nor to any new motor vehicle while being taken by any private person from the place of delivery to him by any dealer, distributor or manufacturer, to the home or place of business of such private person.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 10.

AN ACT to create subsections (2m) and (2n) of section 29.28 of the statutes, relating to ice fishing.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Two new subsections are added to section 29.28 of the statutes to read: (29.28) (2m) As an emergency provision, ice fishing with not more than three lines is permitted until January 1, 1932, in the following waters:

(a) Barron county: all waters.

(b) Buffalo county: all waters.

(bm) Burnett county: all waters except Clam lake.

(br) Crawford county: all waters.

(c) Dane county: all waters.

(cm) Douglas county: Allouez Bay, Superior Bay, St. Louis Bay, and the St. Louis river connected with Lake Superior.

(d) Eau Claire county: Beef Slough and Half Moon lake.

(e) Jackson county: all waters.

(f) Jefferson county: all waters except in Spring lake.

(g) La Crosse county: all waters.

(h) Kenosha county: all waters except Lilly lake.

(hm) Marathon county: Lake Wausau and that portion of the Eau Claire river within said county.

(i) Oconto county: the Oconto river.

(im) Outagamie county: all waters.

(j) Pepin county: all waters.

(k) Pierce county: all waters except Lake St. Croix.

(1) Polk county: all waters except those specified in paragraph (n) of subsection (1) of this section.

(1m) Portage county: the Wisconsin river and Plover river.

(ln) Racine county: Eagle lake.

(m) Rock county: the portion of Lake Koshkonong in Rock county.

(n) St. Croix county: all waters except Lake St. Croix and the St. Croix river up to and including the Dells.

(o) Trempealeau county: all waters except Lake Marinuka.

(om) Vernon county: all waters.

(p) Walworth county: Lake Delavan, Lake Turtle and Lake Geneva.

(pm) Washburn county: all waters except those specifically closed to ice fishing by paragraph (s) of subsection (1) of this section.

(q) Washington county: all waters except Silver, Lucas and Hackbarth lakes.

(r) Waukesha county: all waters except Lake Tichigan, Eagle lake and Brown's lake.

(2n) If the conservation commission, after hearings and investigations, shall find that the emergency referred to in subsection (2m) still exists or that ice fishing may be permitted without endangering the fish supply, it may extend the provisions

of subsection (2m) as to any waters therein named for such periods as it may designate.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 12.

- AN ACT to amend subsection (1) of section 76.34 of the statutes, relating to the annual license fees payable by domestic life insurance companies.
- The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (1) of section 76.34 of the statutes is amended to read: (76.34) (1) If such company, corporation or association is organized under the laws of this state, it shall pay as a license fee for the year 1931 and annually thereafter, three and one-half per centum upon its gross income from all sources for the year ending December thirty-first, next prior to said first day of March, excepting therefrom interest required to provide and maintain reserves according to the laws of this state, income
