CHAPTER 151.

AN ACT to amend paragraph (b) of subsection (3a) of section 201.04 of the statutes, relating to group life insurance for the members of labor unions.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Paragraph (b) of subsection (3a) of section 201.04 of the statutes is amended to read: (201.04) (3a) (b) Life insurance covering the members of any labor union or any association of public employes, written under a policy issued to such * * * organization which shall be deemed to be the employer for the purposes of this chapter, the premium on which is to be paid by the * * * organization or by the * * * organization and its members jointly, and insuring * * * all of its members * * * for amounts of insurance based upon some plan which will preclude individual selection, for the benefit of persons other than the * * * organization or its officials; provided that * * * all members of a labor union or any association of public employes may be insured; provided also that when the premium is to be paid by the * * * organization and its members jointly and the benefits are offered to all eligible members, not less than seventy-five per centum of such members may be so insured.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 152.

AN ACT relating to moneys collected and bills outstanding at the Grand Army Home for Veterans prior to the time said home passed under the administration of the adjutant general, and making an appropriation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The adjutant general is directed to deposit in the general fund the sum of two thousand six hundred forty-eight

dollars and seventy-six cents realized from the sale of miscellaneous property at the Grand Army Home for Veterans prior to the time he took charge of the home. Such sum is hereby appropriated to the adjutant general and added to the appropriation made in paragraph (a) of subsection (3) of section 20.15 for the fiscal year ending June 30, 1931.

SECTION 2. The adjutant general is authorized and directed to pay from the appropriation made in paragraph (a) of subsection (3) of section 20.15 for the fiscal year ending June 30, 1931, bills in a total amount of three thousand thirty-seven dollars and thirty-eight cents incurred at the Grand Army Home for Veterans prior to the time he took charge of said home.

SECTION 3. This act shall take effect upon passage and publication.
