## CHAPTER 322.

AN ACT to amend subsection (4) of section 357.13 of the statutes, relating to insane person guilty of criminal offenses.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (4) of section 357.13 of the statutes is amended to read: (357.13) Any person committed under the provisions of this section shall at any time after said commitment be entitled to a rehearing as to such sanity as provided and according to procedure outlined in section 51.11. If it shall be determined, \* \* \* pursuant to any such re-examination, that the insanity or feeble-mindedness of such accused person is incurable he shall be treated and disposed of as persons incurably insane or feeble-minded are required by law to be treated; but no such person shall be removed or discharged from said hospital or home except upon the order of the court having jurisdiction \* \* \* over such person for trial, sentence or commitment.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 323.

AN ACT to amend section 45.06 of the statutes, relating to rooms furnished by counties to civic, patriotic, educational and historical societies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 45.06 of the statutes is amended to read: 45.06 The action of any county board or municipality, or department thereof, in granting soldiers of the Civil War, Spanish American War or World War, any other civic, patriotic, educa-

tional or historical society, rooms and space within public buildings for the establishment of memorial halls and museums, and occupancy thereof by \* \* its members, is hereby authorized and confirmed. Such county board or municipality is hereby empowered and authorized to permit the use and occupancy of such rooms and space for such term and subject to such conditions and provisions as may be by them imposed; provided, however, that any contract, lien or agreement between said county board, municipality or department thereof and any such \* \* \* organization now in force shall continue in force according to the terms thereof.

## CHAPTER 324.

AN ACT to create section 101.32 of the statutes relating to the destruction of obsolete records of the industrial commission.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 101.32 Whenever necessary to gain needed vault space, the industrial commission may turn over to the superintendent of public property for destruction obsolete records in its possession, as follows:

- (a) Correspondence, after five years;
- (b) Inspection reports, after five years;
- (c) Reports made to the industrial commission, after five years;
- (d) Orders and findings of fact of the commission entered pursuant to Chapter 102, after five years.

SECTION 2. This act shall take effect upon passage and publication.
