

SECTION 2. 103.67 (2) of the statutes is amended to read:

103.67 (2) No minor under fourteen years of age shall be employed, or permitted to work in any gainful occupation at any time; except that minors under fourteen may be employed in agricultural pursuits as provided in section 103.77, and minors from twelve to fourteen may be employed during school vacations as provided in subsection (3) of this section and in public exhibitions as provided in section 103.78, and that boys of thirteen may be employed in street trades, *and boys of twelve may be employed in house to house street trades*, as provided in sections 103.21 to 103.36.

SECTION 3. 103.71 (2) of the statutes is amended to read:

103.71 (2) No permit shall be issued authorizing the employment of any minor under fourteen years at any time; except for minors twelve years and over to appear in public exhibitions as provided in section 103.78 and for boys thirteen years of age in street trades, *and for boys twelve years of age in house to house street trades*, as provided in sections 103.21 to 103.31.

CHAPTER 351.

AN ACT to amend 19.01 (7) and 330.20 (2) of the statutes, relating to bonds of public officials and employes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 19.01 (7) of the statutes is amended to read:

19.01 (7) This section shall not be construed as requiring any particular officer to furnish or file either an official oath or an official bond. It is applicable to such officers only as are elsewhere in these statutes or by the constitution *or by special, private or local law* required to furnish such an oath or bond. Provided, however, that whether otherwise required by law or not, an oath of office shall be filed by every member of any board or commission appointed by the governor, and by every administrative officer so appointed, also by every secretary and other chief executive officer appointed by such board or commission.

SECTION 2. 330.20 (2) of the statutes is amended to read:

330.20 (2) An action *by the state or any of its departments or agencies or by any county, town, village, city, * * * school district or other municipal unit* to recover any sum of money by reason of the breach of an official bond *or the breach of a bond of any nature whatsoever, whether required by law or not, given by a public officer or any agent or employe of a governmental unit*; such period to commence running when such * * * *governmental unit* receives knowledge of the fact that a default has occurred in some of the conditions of such bond and that it was damaged because thereof.

CHAPTER 352.

AN ACT to amend 85.01 (4) (g) of the statutes, relating to the licensing and registration of municipality-owned and operated vehicles.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

85.01 (4) (g) of the statutes is amended to read:

85.01 (4) (g) Automobiles, motor trucks, motor delivery wagons, trailers or semitrailers owned and operated exclusively in the public service by the state of Wisconsin, or by any county or municipality thereof, and motor busses owned and operated by a private school or college and used exclusively for transportation of students to and from such school or college and not used for hire shall be registered by the motor vehicle department upon receipt of a properly filled out application blank accompanied by the payment of a registration fee of \$1 for each of said vehicles or trailers. *The foregoing provision shall also apply to automobiles, motor trucks, motor delivery wagons, trailers or semitrailers loaned to the state or any county or municipality thereof for the duration of the war emergency and operated exclusively by the state or such county or municipality for civilian defense purposes.* The motor vehicle department shall furnish * * * one number plate * * * for each automobile, motor
