CHAPTER 420.

AN ACT to amend 110.03 (5) and 110.06 (1), (3) and (4) and 194.19 of the statutes, relating to transferred functions and to uniform orders, penalties, and appeals of the motor vehicle department.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 110.03 (5) of the statutes is amended to read:

110.03 (5) All powers, duties and functions vested in the public service commission by virtue of chapter 194, excepting those included in the provisions of paragraphs (a) and (c) of section 194.02, of section 194.03 (3) and (6), of section 194.18 (2), (3), (4), (5), (6), (7) and (9), *section 194.19*, sections 194.21 to 194.28, sections 194.30 and 194.35 and section 194.36 (2), (4), (5), (6), (7), (7a), (8) and (9), sections 194.34 and 194.46 and section 194.48 (5) relating and supplemental to the granting, amendment, revocation, suspension or assignment of common motor carrier certificates or contract motor carrier licenses or the regulation of rates and service of common and contract motor carriers.

SECTION 2. 110.06 (1), (3) and (4) of the statutes are amended to read:

110.06 (1) The commissioner of the motor vehicle department shall have the power to make such reasonable *and uniform orders*, rules and regulations not inconsistent with law as he may deem necessary to the discharge of the powers, duties and functions vested in such department. *Such orders, rules and regulations shall take effect 20 days after publication in the official state paper.* He shall also have power and authority to prescribe forms for applications, notices and reports required by law to be made to the department or which may be deemed necessary to the efficient discharge of all such powers, duties and functions.

(3) All orders, determinations, rules and regulations made by the commissioner of the motor vehicle department under the powers and authority transferred to him by this chapter shall have the same force and effect as is provided for similar orders, determinations, rules and regulations of * * * *any* department, made under the powers transferred hereby, and violations * * * *thereof pertaining to chapter 85 shall be punished as provided by section 85.01 (12), to chapter 194 as provided by section 194.17, and to section 129.11 as provided by section 129.11 (13).*

(4) The orders and determinations of the commissioner of the motor vehicle department made under the powers and authority transferred by this chapter * * * *and all other orders and determinations of the commissioner of the motor vehicle department shall be subject to appeal and judicial review in the manner provided by chapter 196 for appeal and review of orders and determinations of public service commission.*

SECTION 3. 194.19 of the statutes is amended by substituting "public service commission" for "motor vehicle department" wherever those words occur.

CHAPTER 421.

AN ACT to amend 236.05 (3) of the statutes, relating to certificate requirements to entitle final plats to record.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

236.05 (3) of the statutes is amended to read:

236.05 (3) The owner's certificate shall be signed or consented to in writing on the plat by all persons holding an interest in the fee of record or by being in possession *and if the land is mortgaged by the mortgagee.* These signatures shall be signed, witnessed and acknowledged as conveyances are required by sections 235.19 and 235.22 to entitle them to registration.
