**CHAPTER 165.**

AN ACT to repeal and recreate 84.20 of the statutes, relating to state repair of damages done to public highways of municipalities used in state highway repair and construction and making an appropriation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 84.20 of the statutes is repealed and recreated to read:

84.20 Damage to any county trunk or town highway or city or village street caused by reason of its use as a detour designated by the highway commission or for hauling materials incident to the maintenance, repair or construction by the highway commission of any state trunk highway or street over which a state trunk highway is routed, shall be repaired by the highway commission and the cost thereof paid from funds appropriated and available to the commission for the maintenance and improvement of state trunk highways and connecting streets under sections 20.49 (4), 20.49 (7c), 20.49 (9) or 20.495.

**CHAPTER 166.**

AN ACT to amend 29.29 (1) of the statutes, relating to killing fish with noxious substances.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

29.29 (1) of the statutes is amended to read:

29.29 (1) No person shall take, capture or kill fish of any variety in any waters of this state by means of dynamite or other explosives or poisonous or stupefying substances or devices; or place in any waters of this state explosives which might cause the destruction of fish, except for the purpose of raising dead bodies whenever ordered by the public authorities, or for the purpose of clearing a channel or breaking a log jam; or have in his possession or under his control, upon any inland

waters, any dynamite or other explosives or *poisonous or stupefying substances or devices* for the purpose of taking, catching or killing fish. Violations of this subsection shall be punished by a fine of not less than \$200 nor more than \$500, or by imprisonment in the county jail not less than 9 months nor more than one year, or by both such fine and imprisonment.

AN ACT to create 370.01 (50) of the statutes, relating to a definition of "chiropractor".

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

370.01 (50) of the statutes is created to read:

370.01 (50) CHIROPRACTOR. "Chiropractor" means a person holding a license issued by the state board of examiners in chiropractic.

### CHAPTER 168.

AN ACT to amend 29.09 (1) of the statutes, relating to hunting licenses.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

29.09 (1) of the statutes is amended to read:

29.09 (1) Except as expressly provided, no person shall (a) hunt with a gun any wild animal, or (b) trap any game, or (c) take, catch or kill fish or fish for fish in inland water of this state unless a license therefor has been duly issued to him which shall be exhibited to the conservation commission or its deputies on demand. Such licenses shall be issued to and obtained by only natural persons *lawfully entitled thereto*, and in case of resident hunting, trapping or fishing licenses, shall be issued
