ated in counties having a population of not less than 300,000, shall be paid such salary as shall be fixed by the electors at the annual town meeting, not to exceed \$2,400 per annum, which shall be in lieu of compensation per diem. The clerks of the polls and town clerks shall be entitled to a compensation of \$3 per day, and at the same rate for parts of a day actually and necessarily devoted by them to the service of the town and in the discharge of any of the duties of their respective offices required of them by law, unless a different compensation shall have been fixed by the annual town meeting. No town officer shall be entitled to pay for acting in more than one official capacity or office at the same time.

## CHAPTER 365.

AN ACT to create 201.06 of the statutes, relating to coverages written by casualty companies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

201.06 of the statutes is created to read:

201.06 CASUALTY COMPANIES; ADDITIONAL COVERAGES. Any corporation which is licensed to transact the business of insurance under section 201.04 (10) may also insure (a) against loss of or damage to any property resulting from larceny, robbery, forgery, fraud, confiscation or wrongful conversion, disposal or concealment by any person or persons or from any attempt at any of the foregoing and when written in conjunction with any of the coverages provided for under said subsection (10) may insure against vandalism and malicious mischief and (b) against loss of or damage to moneys, coins, bullion, securities and (c) against loss or damage to notes, acceptances or any other valuable papers or documents, resulting from any cause, except while in the custody or possession of and being transported by any carrier for hire or in the mail and (d) personal property of individuals when written under an all-risk type of policy commonly known as the "Personal Property Floater." Provided that all insurance under (c)

and (d) shall be subject to the provisions of sections 200.17 and 201.59.

## CHAPTER 366.

AN ACT to revise chapter 56 of the statutes, relating to prison industries and labor.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The title to chapter 56 of the statutes shall read:

CHAPTER 56

PRISON LABOR

Section 2. 56.01 is revised to read:

- 56.01 PRISON INDUSTRIES ANDPRODUCTS. (1) The department may establish industries and purchase machinery and raw materials for the employment of prisoners in the Wisconsin state reformatory and Wisconsin state prison, in manufacturing articles for the state and its political divisions and any tax-supported institution or agency and for sale thereof to other states or political divisions thereof or to the United States and shall fix the price of all produce as near the market price as possible. In fixing the price of motor vehicle license plates and highway signs and markers to this state or any division thereof the value of labor of each prisoner employed at such work shall be calculated at the rate of \$1.75 per day, of which 25 cents shall be allowed as pay to the prisoner or as a benefit to his dependents.
- (2) The department may lease or purchase land within the state for the employment of prisoners. It may construct barracks for their safe-keeping outside the prison proper.
- (3) The department shall include in its biennial report to the governor, a detailed statement showing the amount of the various articles produced in the prison industries, the disposition of these articles, the cost of the material, the machinery installed and the cost thereof, the land purchased or leased and the cost thereof and the rates and total amount of wages paid or credited to prisoners pursuant to this section.
