CHAPTER 426.

AN ACT to create 343.08 of the statutes, relating to causing fires by tobacco smoking and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

343.08 of the statutes is created to read:

343.08 CAUSING FIRES BY TOBACCO SMOKING. (1) Any person who, by smoking, or attempting to light or to smoke cigarettes, cigars, pipes, or tobacco, in any manner in which lighters, or matches are employed, shall, in a careless, reckless, or negligent manner, set fire to any bedding, furniture, curtains, drapes, house or any household fittings, or any part of any building specified in subsection (2), so as to endanger life, or property in any way, or to any extent, shall be fined not less than \$10 nor more than \$50, together with costs, and in lieu of payment thereof may be imprisoned not less than one day nor more than 15 days.

(2) In each sleeping room of all hotels, rooming houses, lodging houses and other places of public abode, a plainly printed notice shall be kept posted in a conspicuous place advising tenants of the provisions of this section.

CHAPTER 427.

AN ACT to amend 188.085 of the statutes, relating to the dissolution of units of the American Legion.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

188.085 of the statutes is amended to read:

188.085 Any post, county, district council, department or other unit of the American Legion or of the auxiliary of the American Legion which has become a body corporate under the provisions of section 188.08 may change its name or dissolve by the adoption of a written resolution to that effect, by a vote of a majority of its members present at a meeting called

for that purpose and by filing the same as herein provided. Such resolution, with a certificate thereto affixed, signed by the commander and adjutant, or like or similar officers, stating the facts, including the date of the adoption of such resolution, the number of members present at such meeting, and the number of members who voted for the adoption of the resolution, shall be forwarded to and filed with the secretary of state, and thereupon the name of such corporation, shall be changed or the corporation shall cease to exist, as the case may be * * * .

In lieu of the foregoing method of dissolution, any corporation formed under section 188.08 may be dissolved by the filing of a certificate in the office of the secretary of state reciting that such corporation has ceased to be a unit of the American Legion or its auxiliary. Such certificate shall be signed by the national commander and national adjutant of the American Legion or by the state commander and state adjutant of the American Legion, department of Wisconsin. In the case of units of the auxiliary the certificates shall be signed by the national president and national secretary or the department president and department secretary. Corporations dissolved under this section shall continue to have corporate existence for the time and purposes specified in section 181.02. No fee shall be charged by the secretary of state for such filing.

CHAPTER 428.

AN ACT to amend 147.23 (3) of the statutes, relating to chiropractic regulation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

147.23 (3) of the statutes is amended to read:

147.23 (3) Application for a license to practice chiropractic shall be made to the board of examiners in chiropractic, accompanied by sufficient and satisfactory evidence of good moral character, preliminary education equivalent to graduation from an accredited high school of this state, graduation from a reputable school of chiropractic, *approved and recognized by the board of examiners in chiropractic*, having a residence
