CHAPTER 544.

AN ACT to amend section 4, 2 and section 13, 1 of chapter 549 of the laws of 1909 as last amended by chapter 443, laws of 1935, relating to the salaries of the judges of the civil court of Milwaukee county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 4, 2 and section 13, 1 of chapter 549 of the laws of 1909 as last amended by chapter 443, laws of 1935 are amended to read:

(Chapter 549, laws of 1909) Section 4. 2. The board of supervisors of said county shall also provide for the payment of the salaries of the judges, clerks, deputy clerks, deputy sheriffs and assistants of said court, and any other necessary expenses of said court * * *.

Section 13. 1. The judges of said court shall each receive an annual salary of * * * \$8,500, to be paid in monthly installments by the county of Milwaukee in the same manner as the salaries of other officers of said Milwaukee county are now paid.

CHAPTER 545.

AN ACT to amend 73.02 (2) of the statutes, relating to the commissioner of taxation.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

73.02 (2) of the statutes, as amended by chapter 332, laws of 1947, is amended to read:

73.02 (2) The governor by and with the advice and consent of the senate shall appoint a commissioner of taxation, who shall serve for a 6-year term and until his successor has been appointed and qualified * * * * * * The commissioner to be initially appointed shall be appointed for a term to * * * begin on August 1, 1947. Successors shall be appointed at least 30 days prior to the expiration of the term to be filled by such appointment and during the biennial session of the legislature within which the term of the commissioner then holding office shall expire. Vacancies shall be filled in the manner provided in section 17.20. The commissioner shall take and file the official oath before entering upon the performance of his duties. Such appointments shall be made on the basis of recognized and demonstrated interest in and knowledge of the problems of taxation and shall be made without regard to party affiliation, or because of interest in any special organized group. The commissioner shall receive an annual salary of \$8,500 and there shall be provided for the use of the department of taxation adequate offices or rooms in the state capitol or elsewhere in the city of Madison.
