WHEREAS, Certain civil service salary adjustments made jointly by the emergency and personnel boards in April 1946 and pursuant to legislation enacted by the special session of the legislature in July 1946 will terminate on February 28, 1947; and

WHEREAS, Since approximately 75 per cent of the state budget normally covers salaries, problems involving personnel administration including employe morale, performance and output, departmental organization, flow of work, and related matters are of vital concern to the legislature; now, therefore, be it

Resolved by the Assembly, the Senate concurring, That a special joint committee be constituted consisting of 2 senators and 3 assemblymen to be appointed as are standing committees in the respective houses to consider the report of Griffenhagen and Associates, and to hold hearings and make recommendations thereon, to hold hearings on the need for adjusting civil service salary schedules, cost of living salary bonuses, uniform working hours, new personnel needs, and efficiency and performance of employes. Said committee may also study any related personnel conditions it deems advisable. Said committee shall have the authority to call before it any state officer, department head, or employe, and may invite any other interested persons to present their views and recommendations. Said committee shall report to this session of the legislature within 30 days, if possible, from the date of its appointment, or at any time during its existence, its findings and recommendations together with such drafted bills to carry out its recommendations as the committee may deem advisable.

#### JOINT RESOLUTION

Directing the adjutant general to take necessary steps to accomplish the repair by the federal government of the Wisconsin State Memorial located at the Vicksburg National Military Park.

WHEREAS, The Wisconsin State Memorial built by this state at considerable cost at the Vicksburg National Military Park was, on March 28, 1944, extensively damaged by lightning; and

WHEREAS, Because of the war the only work that was done on the monument was the securing by cables of the broken and dislodged stone panels to prevent their falling; and

WHEREAS, The responsibility for the repair, upkeep and maintenance of the memorial is that of the National Park Service of the United States Department of the Interior; and

WHEREAS, It is believed that the necessary materials are now available so that such repair can be undertaken at this time; and

WHEREAS, It is presumed that the park visitation has since the close of the war considerably increased; now, therefore, be it

Resolved by the Senate, the Assembly concurring, That the adjutant general of the state of Wisconsin be and he is hereby requested to initiate such steps with the National Park Service as are necessary to accomplish the repair of the Wisconsin Memorial at the Vicksburg National Military Park at the earliest date possible without any cost to the state of Wisconsin.

## JOINT RESOLUTION
