JOINT RESOLUTION

Requesting the "Freedom Train" to exhibit at Madison on the Wisconsin Centennial Day.

WHEREAS, The "Freedom Train", sponsored by the federal Department of Justice, the Library of Congress and the National Archives, will leave in September, 1947 on a 25,000-mile tour of the 48 states, and

WHEREAS, The train will carry and exhibit to the people of the United States documents and letters emblematic of our national freedom and in fact forming the foundation of our liberties, thus inspiring the people to continue to resist any encroachment thereon, and

WHEREAS, Among other historical documents to be exhibited either in the original draft or by facsimile, will be the Magna Carta, the Declaration of Independence, the Treaty of Paris, the Constitution, the Bill of Rights, the Virginia Statute of Religious Rights, the Emancipation Proclamation, Washington's first Inaugural Address and Lincoln's Gettysburg Address, and

WHEREAS, President of the University Fred and Acting Governor Rennebohm have invited the train to exhibit at Madison, the capital of the state, seat of the state university and home of the State Historical Society, and sponsors of the train have already tentatively designated June 3, 1948 for such visit, and

WHEREAS, May 29, 1948 will be the one-hundredth anniversary of Wisconsin's admission to statehood and will be celebrated throughout the state, and particularly in Madison, by appropriate ceremonies; now, therefore, be it
