CHAPTER 466

AN ACT to create 20.005 (2) (a) (lines 496a to 496j) of the statutes, to appropriate \$1,668.96 from the general fund to Kendall V. Haughtelin, Anthony and Marie Russell, Ralph G. Keck, Karl Ullmer, Suzanne Schroeder, H. L. Self, Kurt Bendit, Max Pittleman, Robert O. and Florence E. Fohr and the Service Fire Insurance Company for payment of claims made by them against the state.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.005 (2) (a) (lines 496a to 496j) of the statutes are created to read:

SECTION 2. There is appropriated from the general fund \$1,668.96 to the persons named herein in the respective amounts set forth above in payment of the claims made by such persons against the state. Kendall V. Haughtelin incurred medical expenses of \$56.50 for his wife, resulting from an accident at the State Fair grounds on August 19, 1956. Anthony and Marie Russell paid \$410.99 in Wisconsin income taxes, under the mistaken belief that they were residents of Wisconsin. Ralph G. Keck received an award of workmen's compensation which, due to an error, was \$330.50 less than it should have been. Karl Ullmer, a shareholder in a building and loan association, failed to receive liquidating dividends of

\$293.28 because of an error in mailing notices, and that amount subsequently was paid to the commissioner of savings and loan associations. Suzanne Schroeder suffered damages of \$30 to her coat, due to the negligent spilling of a lye solution in a University of Wisconsin classroom. H. L. Self suffered damages of \$26 to his automobile, resulting from the negligent handling of a steer at the University of Wisconsin. Kurt Bendit and Max Pittleman suffered damages of \$162.08 and \$59.70, respectively, when their automobiles were struck by vehicles operated by the Wisconsin National Guard. Robert O. and Florence E. Fohr suffered damages of \$100 when an airplane operated by the Wisconsin National Guard landed on their farm. An automobile owned by Halfdan Schroeder and insured by Service Fire Insurance Company of New York was damaged to the extent of \$199.91 when it was struck by a vehicle operated by the Wisconsin National Guard. Acceptance of these appropriations shall operate as a full and complete release to the state for any claim on the part of the persons listed above on account of such damages.
