CHAPTER 455

AN ACT to renumber and amend 35.85 (2) ; to amend 35.85 (6) and 43.14, as amended by chapter 18, laws of 1965; and to create 35.85 (2) (b) of the statutes, relating to depository libraries for Wisconsin state documents.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 35.85 (2) of the statutes, as amended by chapter 18, laws of 1965, is renumbered 35.85 (2) (a) and amended to read:

35.85 (2) (a) Of parts of official reports, pamphlets and magazines, and pamphlet laws, printed by authority of ss. 35.28 and 35.29, one copy to each person named in lists filed for the purpose of such distributions by the respective state agencies upon whose requisition the same were printed except that blocks of such publications may be allotted to the requisitioning agency for official use subject to approval of the director. The lists filed by the state superintendent and by the ~~Wisconsin library commission~~ shall designate, by counties, the matter to be distributed to schools of all kinds and school libraries in such counties, respectively, and the matter so designated shall be shipped by freight or express to the county superintendents of schools, who shall make the ultimate distribution at the expense of the counties respectively.

SECTION 2. 35.85 (2) (b) of the statutes is created to read:

35.85 (2) (b) Of every governor's message to the legislature and of every public document or circular printed at the expense of this state including, without limitation because of enumeration, the operating reports of the several departments and agencies of state government and reports publishing the results of studies by state departments and agencies, to every depository library under s. 43.14 the number of copies designated by the Wisconsin library commission.

SECTION 3. 35.85 (6) of the statutes, as amended by chapter 18, laws of 1965, is amended to read:

35.85 (6) The Wisconsin library commission *shall receive for its own use one copy of each document distributed under sub. (2) (b) and shall file with the director lists of public documents to be distributed to libraries designated as depositories of public documents under s. 43.14.*

SECTION 4. 43.14 of the statutes, as amended by chapter 18, laws of 1965, is amended to read:

43.14 The director of the library commission ~~is directed to shall ascertain and report to the department of administration what which~~ public libraries in ~~the this~~ state, ~~containing more than 1,000 volumes,~~ including the libraries of state colleges, academies and public or private colleges, can suitably care for and advantageously use ~~copies of the public documents printed by~~ *at the expense of this state including printing under ss. 35.28 and 35.29.* The director shall designate such libraries as depositories of state documents and shall, ~~from time to time, prepare.~~ *The secretary shall furnish lists of such depositories for the use of to the department of administration, to govern the distribution under s. 35.85 (2) (b).* ~~The department of administration shall furnish each library which is designated as a depository of state documents one set of public documents, as they are published, and also copies of such other reports and documents, printed at the expense of the state, as may be of general interest and supplied to it in sufficient numbers to meet such demand.~~ *Such lists shall show, for each depository library, the number of copies of each printed state document it is to receive.*
