## CHAPTER 326, LAWS OF 1967

AN ACT to repeal 13.94 (2) and (3) (c), as affected by chapter 26, laws of 1967 and 20.930 (1m) (c) 1, 6, 7 and 8m; to renumber 13.94 (3) (title), (intro.), (a), as affected by chapter 26, laws of 1967, (b), and (e), as affected by chapter 26, laws of 1967; to amend 20.520 (1) (a) and (b), as affected by the laws of 1967, 20.930 (2) (a), and chapter 75, laws of 1967, section 25 (3) (b); and to create 20.930 (2) (c) of the statutes, relating to the qualifications for state auditor, the

1967-69 appropriation for the legislative council, salaries of department heads and the natural resources council on state agencies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Section 1. 13.94 (2) and (3) (c), as affected by chapter 26, laws of 1967, of the statutes are repealed.

Secrior 2. 13.94 (3) (title), (intro.), (a), as affected by chapter 26, laws of 1967, (b) and (c), as affected by chapter 26, laws of 1967, of the statutes are renumbered 13.94 (2) (title), (intro.), (a), (b) and (c), respectively.

SECTION 3. 20.520 (1) (a) and (b) of the statutes, as affected by the laws of 1967, are amended to read:

20.520 (1) (a) *Biennially*, the amounts in the schedule for the execuecution of the functions of the joint legislative council under s. 13.81 and its committees to conduct research, and to develop studies on such problems as are referred to the council by the legislature. Expenditures from this appropriation shall be by voucher signed by the chairman or the executive secretary of the council.

(b) Biennially, the amounts in the schedule for general contingent expenses to be expended on the order of the chairman or executive secretary of the council at their discretion, but a statement of all such expenditures shall be rendered to the legislature at the beginning of each regular session.

SECTION 4. 20.930 (1m) (c) 1, 6, 7 and 8m of the statutes are repealed.

SECTION 5. 20.930 (2) (a) of the statutes is amended to read.

20.930 (2) (a) Legislative council. Executive secretary, elerical and export assistants.

Section 6. 20.930 (2) (c) of the statutes is created to read:

20.930 (2) (c) Joint committee on legislative organization: state auditor, chief of the legislative reference bureau, revisor of statutes.

SECTION 7. Chapter 75, laws of 1967, section 25 (3) (b) is amended to read:

(Chapter 75, laws of 1967) Section 25 (3) (b). Natural resources council of state agencies, previously named the natural resources committee of state agencies, under section 23.26 of the statutes. The membership of the natural resources council of state agencies shall be reconstituted to consist of 45 17 members representing. Fifteen of the members shall represent 13 officers, departments or independent institutions and agencies as follows, and each member shall be designated by the respective named officer or head of the department or independent institution or agency: the governor, the attorney general, the public service commission, the board of regents of state universities, the departments of administration, of agriculture, of local affairs and development, of public instruction and of transportation, and the divisions of health, of conservation and of resource development shall each designate one member. The university of Wisconsin shall designate 3 members to represent, respectively, the co-operative extension services, the geological and natural history survey and the water resources center. In addition, the chairman of the legislative council shall designate 2 members of the council to be members.
