CHAPTER 77, Laws of 1981

AN ACT to amend 66.054 (19) (d) and 176.32 (1) (d); and to create 66.054 (19) (d) 2 and (dm) and 176.32 (1) (d) 2 and (dm) of the statutes, relating to permitting minors to enter premises licensed to sell beer and liquor to march or drill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 66.054 (19) (d) of the statutes is amended to read:

66.054 (19) (d) A person under 18 years of age may enter and remain, and may be permitted to enter and remain, on:

1. On Class "B" licensed premises if for the purpose of transacting bona fide business other than amusement or the purchase, receiving or consumption of edibles or beverages except a person under 18 years of age who enters for the purpose of transacting business at an auction or a market as defined by sub. (8) (b) 1 may not enter or remain in, or be permitted to enter or remain in, a room in which fermented malt beverage is sold or furnished; or

SECTION 2. 66.054 (19) (d) 2 and (dm) of the statutes are created to read:

66.054 (19) (d) 2. In a room on Class "B" licensed premises separate from any room where fermented malt beverage is sold or served, for the purpose of engaging in marching or drilling with a group of other persons if no fermented malt beverage is sold, furnished or consumed by any person in the room where the minor is present and the minor's presence is authorized under par. (dm).

- (dm) A minor may enter and remain, and may be permitted to enter and remain, on Class "B" licensed premises under par. (d) 2 only if:
- 1. The city, village or town which issued the Class "B" license adopts an ordinance permitting minors to enter and remain on Class "B" licensed premises as provided by par. (d) 2; and
- 2. The law enforcement agency responsible for enforcing the ordinance, after making a determination that the presence of minors on the licensed premises will not endanger the health, welfare or safety of the minors or other members of the community, issues to the Class "B" licensee a written authorization permitting minors to be present on the premises under par. (d) 2 on the date specified in the authorization. The licensee shall obtain a separate authorization for each date on which minors will be present on the premises.

SECTION 3. 176.32 (1) (d) of the statutes is amended to read:

176.32 (1) (d) A person under 18 years of age may enter and remain:

1. On premises on which intoxicating liquor is sold if for the purpose of transacting bona fide business other than amusement or the purchase, receiving or consumption of edibles or beverages except a person under 18 years of age who enters "Class B" licensed premises for the purpose of transacting business at an auction or a market as defined by s. 66.054 (8) (b) 1 may not remain in, or be permitted to enter or remain in, a room in which intoxicating liquor is sold or furnished, or

SECTION 4. 176.32 (1) (d) 2 and (dm) of the statutes are created to read:

- 176.32 (1) (d) 2. In a room on "Class B" licensed premises separate from any room where intoxicating liquor is sold or served, for the purpose of engaging in marching or drilling with a group of other persons if no intoxicating liquor is sold, furnished or consumed by any person in the room where the minor is present and the minor's presence is authorized under par. (dm).
- (dm) A minor may enter and remain, and may be permitted to enter and remain on "Class B" licensed premises under par. (d) 2 only if:
- 1. The city, village or town which issued the "Class B" license adopts an ordinance permitting minors to enter and remain on "Class B" licensed premises as provided by par. (d) 2; and
- 2. The law enforcement agency responsible for enforcing the ordinance, after making a determination that the presence of minors on the licensed premises will not endanger the health, welfare or safety of the minors or other members of the community, issues to the "Class B" licensee a written authorization permitting minors to be present on the premises under par. (d) 2 on the date specified in the authorization. The licensee shall obtain a separate authorization for each date on which minors will be present on the premises.
