1983 Wisconsin Act 499

AN ACT *relating to* authorizing the department of natural resources to exchange certain lands for other lands.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Nonstatutory provisions; land exchange. (1) AUTHORIZATION. On or before January 1, 1985, the department of natural resources is authorized to convey to Kenneth Glembin all rights, title and interest in the 2 parcels of land described in subsections (2) and (3) if Kenneth Glembin agrees to convey to the state all rights, title and interest in the parcel of land described in subsection (4).

(2) LAND DESCRIPTION; PARCEL ONE; FROM THE STATE TO GLEMBIN. A parcel of land located in the SWNW, Section 1, T39N, R9E, Oneida County, described as:

Beginning at the northwest corner of the SWNW, Section 1, Township 39 North, Range 9 East, Oneida County, identified by a one-inch inside diameter iron pipe from which a 12-inch red maple bears S51 degrees E 34.12 feet and a 12-inch white birch bears S56 degrees W 21.71 feet; thence N88 degrees 15 minutes E (this and subsequent bearings are based on a 1971 survey by R. L. Ilg) 850.00 feet, on the north line of the SWNW; thence S1 degree 45 minutes E 50.00 feet; thence S88 degrees 15 minutes W 854.20 feet to the west line of the SWNW; thence N03 degrees 03 minutes E 50.19 feet, on the west line of the SWNW, to the point of beginning. Containing 0.98 acres.

(3) LAND DESCRIPTION; PARCEL TWO; FROM THE STATE TO GLEMBIN. A strip of land located in the NENE, Section 2, T39N, R9E, Oneida County, described as:

Beginning at the northeast corner of Section 2, Township 39 North, Range 9 East, Oneida County, identified by a six-inch square concrete post from which a 28-inch pine stump bears N69 degrees W 45.61 feet, a 20-inch red oak bears N18E 37.49 feet, and an 18-inch red maple bears S79 degrees E 69.17 feet; thence S03 degrees 03 minutes W 765.63 feet on the east line of the NENE to the southeast corner of the NENE, identified by a one-inch inside diameter iron pipe from which a 12-inch red maple bears S51 degrees E 34.12 feet and a 12-inch white birch bears S56 degrees E 34.12 feet; thence west 20.00 feet; thence N03 degrees 03 minutes E 765.63 feet; thence east 20.00 feet, to the point of beginning. Containing 0.35 acres.

(4) LAND DESCRIPTION; PARCEL THREE; FROM GLEMBIN TO THE STATE. A parcel of land located in the NWNW, Section 1, T39N, R9E, Oneida County, described as:

Beginning at the southeast corner of the NWNW of Section 1, Township 39 North, Range 9 East, Oneida County, identified by a one-inch inside diameter iron pipe from which a 14-inch white spruce bears N12 degrees E 24.35 feet and a 15-inch Norway pine bears S33 degrees E 29.50 feet; thence S88 degrees 15 minutes W (this and subsequent bearings are based on a 1971 survey by R. L. Ilg) 464.23 feet on the south line of the NWNW; thence N1 degree 45 minutes W 123.66 feet; thence N88 degrees 15 minutes E 472.12 feet to the east line of the NWNW; thence S1 degree 54 minutes W 123.91 feet, on the east line of the NWNW, to the point of beginning.
