## Enacted by the Legislature in Calendar Year 1985

### 1985 Wisconsin Act 1

AN ACT to renumber 103.21 (2) and (3) and 103.64 (2); to renumber and amend 103.23; to amend 103.67 (2) (c); to repeal and recreate 103.64 (1); and to create 103.21 (2), (4) and (5), 103.23 (2), 103.25 (5), 103.27 (3), 103.64 (intro.) and 103.64 (2), (4) and (5) of the statutes, relating to minors working in fund-raising sales for non-profit organizations, public schools or private schools.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 103.21 (2) and (3) of the statutes are renumbered 103.21 (3) and (6).

SECTION 2. 103.21 (2), (4) and (5) of the statutes are created to read:

103.21 (2) "Nonprofit organization" means an organization described in section 501 (c) of the internal revenue code.

(4) "Private school" has the meaning given in s. 115.001 (3r).

(5) "Public school" has the meaning given in s. 115.01 (1).

SECTION 3. 103.23 of the statutes is renumbered 103.23 (1) and amended to read:

103.23 (1) ~~Except as provided in sub. (2),~~ a minor under 12 years of age shall not be employed or permitted to work at any time in any street trade.

SECTION 4. 103.23 (2) of the statutes is created to read:

103.23 (2) A minor under 12 years of age may work in a fund-raising sale for a nonprofit organization, a public school or a private school under the following conditions:

(a) Each minor must give the nonprofit organization, public school or private school written approval from the minor's parent or guardian.

(b) Each minor under 9 years of age or each group containing one or more minors under 9 years of age must be physically accompanied by a parent or a person at least 16 years of age.

SECTION 5. 103.25 (5) of the statutes is created to read:

103.25 (5) This section does not apply to employment of a minor in a fund-raising sale for a nonprofit organization, a public school or a private school.

SECTION 6. 103.27 (3) of the statutes is created to read:

103.27 (3) This section does not apply to employment of a minor in a fund-raising sale for a nonprofit organization, a public school or a private school.

SECTION 7. 103.64 (intro.) of the statutes is created to read:

103.64 (intro.) As used in ss. 103.64 to 103.82:

SECTION 8. 103.64 (1) of the statutes is repealed and recreated to read:

103.64 (1) "Deputy", "employee", "employer", "employment", "frequenter", "general order", "local order", "order", "place of employment", "safe", "safety", "special order" and "welfare" have the meanings given in s. 101.01.

SECTION 9. 103.64 (2) of the statutes is renumbered 103.64 (3).

SECTION 10. 103.64 (2), (4) and (5) of the statutes are created to read:

103.64 (2) "Nonprofit organization" means an organization described in section 501 (c) of the internal revenue code.

(4) "Private school" has the meaning given in s. 115.001 (3r).

(5) "Public school" has the meaning given in s. 115.01 (1).

SECTION 11. 103.67 (2) (c) of the statutes is amended to read:

103.67 (2) (c) Minors 12 years of age or older may be employed in street trades, and any minor may work
