AN ACT ~~to amend 16.83 (2) (d) and to create 16.83 (2) (cm), 16.83 (2) (e), 16.83 (4), 20.505 (4) (q), 25.17 (1) (q) and 25.35 of the statutes, relating to the duties of the state capitol and executive residence board, creating a state capitol restoration fund and making an appropriation.~~ **Vetoed in Part**

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 16.83 (2) (cm) of the statutes is created to read:

16.83 (2) (cm) Accept for the state donations or loans of works of art or other decorative items and fixtures consistent with par. (c) to be used at the state capitol.

~~SECTION 1m. 16.83 (2) (d) of the statutes is amended to read:~~

~~16.83 (2) (d) Accept for the state donations or loans of furnishings, works of art or other decorative items and fixtures consistent with par. (c) to be used at the executive residence~~

SECTION 2m. 16.83 (2) (e) of the statutes is created to read:

16.83 (2) (e) Accept for the state all gifts, grants and bequests to the state capitol restoration fund, and authorize expenditures from the appropriation under s. 20.505 (4) (q) for the purposes of maintenance, restoration, preservation and rehabilitation of the buildings and grounds of the state capitol, or of artifacts, documents and other historical objects or resources located within and around the state capitol, and for the purpose of the acquisition of replacement or reacquisition of original artifacts, documents and other historical objects or resources, including statuary and works of art, consistent with par. (c), for the state capitol.

SECTION 3. 16.83 (4) of the statutes is created to read:

16.83 (4) FOUNDATION. The board may organize or cooperate in the organization of a private foundation to be operated for the purposes specified in sub. (2) (e).

SECTION 4. 20.505 (4) (q) of the statutes is created to read:

20.505 (4) (q) *State capitol and executive residence board; gifts and grants.* From the state capitol restoration fund, all moneys received by the state capitol and executive residence board from gifts, grants and bequests to be used for the purposes set forth in s. 16.83 (2) (e).

SECTION 5. 25.17 (1) (q) of the statutes is created to read:

25.17 (1) (q) State capitol restoration fund (s. 25.35);

SECTION 6. 25.35 of the statutes is created to read:

25.35 State capitol restoration fund. There is established a separate nonlapsible trust fund designated as the state capitol restoration fund, to consist of all monetary public and private gifts, grants and bequests received by the state capitol and executive residence board under s. 16.83 (2) (e).
