AN ACT to repeal 23.33 (9) (b) 8.; to amend 20.370 (5) (ct), 20.370 (5) (cu), 23.33 (9) (a) and 23.33 (9) (b) 7.; and to create 20.370 (3) (au) of the statutes; relating to: software, communications equipment, and maps for nonprofit organizations that promote the operation of all-terrain and utility terrain vehicles.

23.33 (9) (a) *Enforcement*. The department may utilize moneys received under sub. (2) for all-terrain vehicle and utility terrain vehicle registration aids administration and for the purposes specified under s. 20.370 (3) (as) <u>and (au)</u> and (5) (er) including costs associated with enforcement, safety education, accident reports and analysis, law enforcement aids to counties, and other similar costs in administering and enforcing this section.

**SECTION 6.** 23.33 (9) (b) 7. of the statutes is amended to read:

23.33 (9) (b) 7. Production <u>and acquisition</u> of trail maps and a statewide digital information application for providing safety, regulatory, and riding opportunity information.

**SECTION 7.** 23.33 (9) (b) 8. of the statutes is repealed. **SECTION 8. Effective date.** 

(1) This act takes effect on the day after publication, or on the 2nd day after publication of the 2023 biennial budget act, whichever is later.
