WCD 40.01 State forests. All state-owned forest lands now or that hereafter may come under the jurisdiction of the state conservation commission, located within the following areas, are established and designated as state forests.

(1) AMERICAN LEGION STATE FOREST. Beginning at the northeast corner of section 1, township 39 north, range 9 east;

thence east along the township line between townships 37 and 38 north to the southeast corner of section 36, township 38 north, range 7 east:

thence north along the range line between ranges 7 and 8 east to the southeast corner of section 12, township 38 north, range 7 east;

thence east on section lines to the southeast corner of section 9, township 38 north, range 8 east;

thence south on section lines to the southwest corner of section 22, township 38 north, range 8 east;

thence east on section lines to the southeast corner of section 20, township 38 north, range 9 east;

thence east on section lines to the southeast corner of section 25,

township 39 north, range 9 east; thence north along the range line between ranges 9 and 10 east
