A closed season is established in the following described areas, and it is unlawful for any person to take, catch, kill, hunt, or pursue in any manner any species of wild animals or birds thereon at any time, except deer during the periods established in Wis. Adm. Code section WCD 10.01 (3) (e) as open gun seasons on deer.
