**WCD 11.04 Closed area; deer.** A closed season is established on the following described areas for hunting with any rifle other than a .22 rim-fire, shotguns loaded with single slug or ball, or bow and arrow, and it is unlawful for any person to take, catch, kill, hunt or pursue any species of wild animals or birds thereon with the use of such firearms or bow and arrow at any time.
