Ind 71.01 Identification. The badge as provided in section 103.25, Wis. Stats., shall not be required for boys employed in street trades. In lieu of the badge, identification cards furnished by the commission shall be issued to boys employed in street trades. No charge shall be made for the identification cards.

Ind 71.02 Fees. The department fixes a fee of \$1 for the issuing of each street trade permit and authorizes the retention of 50 cents of the fee by the permit officer as a compensation for his services. The permit officer shall forward 50 cents of the fee to the department to cover the cost of administration, materials and supervision. The department authorizes the Milwaukee school board to retain the full fee as a compensation for their services due to the volume of permits issued, the high cost of facilities and salaries in the city of Milwaukee.

Ind 71.03 Meal periods. At least 30 minutes shall be allowed for each meal period reasonably close to the usual meal period time. In no case shall a boy under 18 years of age be employed or permitted to work more than 6 consecutive hours without a meal period.

Ind 71.04 Hours of work. (1) No boy under 16 years of age shall be employed or permitted to work at any Street Trade more than 8 hours per day or more than 24 hours per week or after the hours of 8:00 P.M. or before the hours of 5:00 A.M.; or, unless he has completed the highest grade of school available to him in accordance with section 103.71, during school hours while the public schools of the city or school district are in session. During regular school vacations boys 14 to 16 years of age may be employed not more than 8 hours per day nor more than 40 hours per week, and during the period from June 15 to September 10, inclusive he may be permitted to work not later than 9:00 P.M.

(2) No boy 16 years of age shall be employed or permitted to work at any Street Trade more than 8 hours per day or more than 40 hours per week, or during such hours as he is required under section 40.77 (2) to attend school. During regular school vacations, boys 16 years of age may be employed not more than 8 hours per day nor more than 48 hours per week.

(3) No boy 17 years of age shall be employed or permitted to work at any Street Trade more than 8 hours per day or more than 48 hours per week or during such hours as he is required under section 40.77 (2) to attend school.
