**VE 2.01 Definition.** "Board" means the veterinary examining board.

**VE 2.02 Age; examination.** No person shall be granted a license to practice veterinary medicine unless they have attained the age of 18 years and have successfully passed an examination conducted by the board.

**VE 2.03 Educational qualifications.** Applicants for license shall submit proof of graduation from an approved school of veterinary medicine. Schools in the United States and Canada, approved by the American veterinary medical association are approved by the board. Graduates of schools outside the United States and Canada are required to complete the educational commission for foreign veterinary graduates certification program of the American veterinary medical association as a pre-requisite to eligibility for examination. The educational commission for foreign veterinary graduates certificate shall accompany the application for examination. Temporary permits may be issued by the board but only to graduates of schools in the United States and Canada.

**VE 2.04 License; application.** Application for license shall be made on forms prescribed by the board and shall be accompanied by:

(1) The examination fee. After notification that the application has been accepted, failure to appear at the examinations shall render the applicant ineligible for examination except upon reapplication accompanied by additional fees.

**VE 2.05 License; fee.** No license or renewal of license shall be issued except upon payment of the annual fee.

**VE 2.08 Temporary permit.** (1) A graduate of a veterinary college approved by the board who meets all requirements for examination may be granted a temporary permit to practice veterinary medicine until the results of the next examination are known provided the applicant is employed and supervised by a licensed veterinarian. Applicants for such temporary permit must provide prior to appearance before the board:

(a) Proof of graduation.

(b) Permit fee of \$10.00.

(c) Three letters of recommendation to be mailed directly by the writer to the administrative secretary at the board's office.

(2) The applicant must personally appear before the board and satisfactorily answer an oral examination by 3 of 4 examining board members in order to obtain a temporary permit. If the applicant does not answer 3 or more examinations satisfactorily, the applicant may be re-examined at the next regularly-scheduled board meeting without paying an additional fee.

(3) A temporary permit shall expire upon:

(a) Failure of the examination.

(b) Failure to apply for and/or to take the next scheduled licensing examination.

**VE 2.09 Examination for licensure.** The examination will consist of 5 equal parts. One part by each of the 5 professional members of the board. The part prepared by the individual board member will consist of both a written and an oral/practical examination.

(1) The board members shall report one score which shall be arrived at by scoring 50% for the written and 50% for the oral/practical portion.

(2) A score of 70% or better is needed from 3 or more of the examiners before a license will be issued.

(3) If, due to a conflict of interest, a board member elects to abstain from examining a candidate for licensure, that member's area of the examination will be conducted by the remaining board members.
