**NR 22.01 Mississippi river boundary water defined.** For the purpose of hook and line fishing in the Mississippi river interstate boundary waters to apply to residents of Wisconsin and nonresident hook and line fishermen properly licensed under sections 29.09 and 29.14, Wis. Stats., all waters from the Chicago, Burlington and Quincy railroad tracks on the east side of the Mississippi river and extending west from said railroad tracks to that part of the river following the boundaries between the state of Wisconsin and Iowa shall be defined as interstate boundary waters.

**NR 22.02 Seasons; limits.** (1) There shall be established and maintained on the interstate boundary waters between the states of Wisconsin and Iowa, which boundary waters are more particularly described under Wis. Adm. Code section NR 22.01, the open and closed seasons for the taking of the various varieties and species of fish, bag limits, size limits, possession limits, and other rules and regulations as set forth herein.

(2) A closed season is established for each variety and species of fish named herein extending for the entire period of each year except the open season period embraced within the specified dates, both inclusive; and except as otherwise expressly provided, no person or persons shall take, catch, kill, or fish for fish of any variety at any time other than the open season therefor, nor have in his possession nor under his control any fish in excess of the daily bag limit, nor below the minimum size limit therefor at any time during the open season as provided in this chapter.

(3) The measurement of length of fish shall be taken in a straight line from the tip of the snout to the utmost end of the tail fin fully extended.

**NR 22.03 Hook and line fishing.** The following seasons, bag limits and other rules and regulations for hook and line fishing are established. The possession limit for each species shall be double the daily bag limit specified in this chapter except that no person shall have in his possession or under his control more than the daily bag limit while

on the ice or waters or while fishing in the Wisconsin—Iowa boundary waters. The measurement of all fish taken shall be in a straight line from the tip of the snout to the utmost end of the tail fin fully extended.

(16) **SALE PROHIBITED; EXCEPTIONS.** No such fish shall be sold, purchased, bartered, offered for sale, or had under control or in possession for the purpose of sale or barter at any time except legally taken and possessed rough fish at all times, catfish 13 inches or over in length in the round or 10 inches dressed with head off and tail on, hackleback sturgeon 25 inches or over, and bullheads. The minimum length for bullheads offered for sale shall be 7 inches dressed with head off and tail on or 9 inches in the round.

(17) **CRAYFISH.** There shall be an open season for the taking of crayfish from the Saturday nearest May 1 to March 1, both dates inclusive, with no bag limit or no size limit.

**NR 22.04 Rough fish.** Rough fish, for the purpose of this chapter, shall be defined as follows: carp, dogfish, redhorse, sheepshead, sucker, eel, eelpout, garfish, buffalo fish, quillback, mooneye, goldeye and shad.

**NR 22.05 Use of hook and line.** (1) Except as otherwise expressly provided by the Wis. Stats. or by department order:

(a) It shall be unlawful, other than fishing through the ice, for any person to take, catch, or kill or fish for fish of any variety with more than 2 lines or 2 poles with 1 line attached to each pole and with 1 hook or bait to each line.

(b) Any fisherman fishing with not more than 1 line or pole with 1 line attached thereto may have attached to such line not more than 2 lures or 2 hooks or 2 baits.

(c) It shall be unlawful for any person to fish with or leave any fish line or lines unattended in any waters; it shall be unlawful for any person to take any fish by snagging or fouling in any manner. Any such fish taken other than in the mouth by snagging or fouling must be immediately returned to the water. It shall also be unlawful for any person to take fish with the aid or use of any firearm or pellet gun in any manner or by any means other than angling or trolling, except that dip nets 3 feet or less in diameter and a gaff may be used for the purpose of landing fish legally hooked.

(d) Any fisherman fishing through the ice with hook and line may fish with not more than 3 lines with not more than one hook attached to each line.

(2) It shall be lawful for any person to take, catch, kill or fish for fish by means of trolling from a motor-driven boat, sailboat or other boat while such boat is in motion.

(3) Fishing near dams. It shall be unlawful for any person to take, capture, or kill fish of any variety or fish for fish by means other than hook or line within 200 feet of any fishway, lock or dam.

(4) No person shall set, place, use, operate or have in possession or under control any snag line or snag pole, snag hook or parts thereof or cluster of fish hooks that might be attached to same designed to be placed in or drawn through the water for the purpose of catching or drawing such hooks into the body of fish or used for that purpose.

**NR 22.06 Use of spears.** It shall be unlawful for any person to use a spear, similar device or bow and arrow in any manner at any time for the purpose of taking, catching, or killing any game fish of any variety, or to have in possession or under control any fish spear, spring gaff or similar device or bow and arrow in a fish house (shanty). Rough fish may be taken by means of spears or bow and arrow in the daytime only.

**NR 22.07 Minnow nets and traps.** (1) No person shall set, use or operate any minnow seine, minnow dip net or minnow trap other than as specified herein.

(2) The following described gear only may be used for the taking of minnows for bait:

(a) *Minnow seines*. Minnow seines shall not exceed 50 feet in length and 6 feet in width flat measure and shall contain mesh not to exceed one-half inch stretch measure.

(b) *Minnow dip nets*. Minnow dip nets used for taking, catching, or killing minnows shall be defined as follows: A piece of netting suspended from a square or round frame not exceeding 6 feet in diameter or 6 feet square and making a bag when lifted not more than 4 feet deep. It shall be unlawful to use dip nets in any manner other than raising and lowering vertically when fishing.

(c) *Minnow traps*. Minnow traps shall be of a length not greater than 24 inches and a diameter of not more than 16 inches with an opening in the throat of the trap not larger than one and one-half inches in diameter. Such traps shall have securely attached to them a label or tag clearly bearing in the English language the name and address of the operator. All minnow traps shall be raised and the minnows removed from them at least once in every 24 hours.

(3) It shall be unlawful for any person except bait dealers licensed pursuant to section 29.137, Wis. Stats., to have in possession or under control more than 600 minnows at any time.

**NR 22.08 Setlines (trot lines) and set hooks.** (1) It shall be unlawful for any person to set or operate more than 8 setlines (trot lines) with not to exceed a total of 50 hooks to each line and not to exceed a total of 400 hooks in the aggregate, for taking, catching, killing, or fishing for catfish 13 inches or over in length, hackleback sturgeon 25 inches or over in length, bullheads and rough fish only; size limits shall conform to the provisions of section NR 22.09; in such fishing it shall be unlawful to use any frog or game fish, either dead or alive, as bait.

(2) Such setlines (trot lines) may be used all year and shall be equipped with a metal tag as prescribed in section 29.37, Wis. Stats. Licenses for such setlines (trot lines) shall be obtained pursuant to section 29.37, Wis. Stats.

(3) At one end of every licensed setline (trot line) there shall be placed and maintained a white flag, not less than 16 inches square, with the upper end of the staff extending at least 2 feet above the water and numbered with figures at least 3 inches in height corresponding with the number of the license authorizing the use of such setline. It shall be lawful to use buoys in lieu of flags providing that same are numbered with figures at least 3 inches in height corresponding with the number of the license authorizing the use of such setlines.

(4) Set or bank poles (set hooks) may be used for the taking, catching, killing or fishing for catfish 13 inches or over in length, hackleback sturgeon 25 inches or over in length, bullheads and rough fish only, during the period of time extending from the Saturday nearest May 1 to the next succeeding October 31; size limits shall

conform to the provisions of section NR 22.09. In such fishing it shall be unlawful to use any game fish or frog, either dead or alive as bait.

(5) Each such set or bank pole (set hook) shall be equipped with a metal tag as prescribed in section 29.36, Wis. Stats. Licenses for such set or bank poles (set hooks) shall be obtained pursuant to section 29.36, Wis. Stats.

(6) Setlines shall be lifted and fish removed at least once every 48 hours.

**NR 22.09 Use of nets.** (1) All commercial fishermen conducting fishing operations shall comply with the provisions of sections 29.34, 29.37 or 29.343, Wis. Stats., whichever applies. It shall be lawful for any person properly licensed to use the following type nets for the taking of all species of fish as listed under subsection (3). Whenever the size of mesh is mentioned, the measurement shall be made by stretch measure except in basket traps (slat nets). Such measurements shall apply to net meshes when in use and no allowance shall be made for the shrinkage due to any cause.

ALL OTHERS. The taking of all other types of fish not mentioned in this section or under the minimum length or weight prescribed in this section is prohibited.

(4) Gill nets with a mesh of 7 inches stretch measure or larger may be used at all times for the taking of rough fish and catfish 13 inches or over in length. All gill nets shall be lifted and emptied of fish at least once in every 48-hour period when set in open water and at least once in every 96-hour period when set under the ice, unless a longer period is granted by the department or its agents.

(5) No net or nets may be used or operated in any waters within 900 feet below any dam on the Mississippi river.

(6) The department may at its discretion require supervision of commercial fishing operations and said department may require the operators of such nets to pay for supervision individually or in groups in the manner they deem advisable, and said department shall fix the amount to be paid each supervising warden. The department may also allow at any time one supervising warden for as many seine, hoop net, frame net (wing net), fyke net or gill net operations as it deems advisable.

(7) The department or its agents may also require at any time any operator of any seine, gill net, buffalo net, frame net, bait net, basket trap (slat net) or setline to cease the fishing operations of such net or nets when said department finds these operations are proving destructive to game fish or for any other good or valid reason.

(8) The use or operations of all other nets excepting those mentioned in this chapter is prohibited in these waters at all times.

(9) Basket traps (slat nets) not more than 6 feet in length and not more than 72 inches in circumferences, over-all dimensions and with one end thereof closed with webbing of a mesh not less than one and one-fourth inches bar or square measure may be used for the taking of

rough fish, bullheads 9 inches or over and catfish 13 inches or over during the period of time extending from the Saturday nearest May 1 to the next succeeding October 31 and shall be equipped with a metal tag as prescribed in section 29.343, Wis. Stats. Such webbing shall be attached in such manner that the length, depth or width of each mesh is not decreased. Licenses for such basket traps (slat nets) shall be obtained pursuant to section 29.343, Wis. Stats. All such nets mentioned above must be lifted at least once in every 48-hour period, unless a longer period is granted by the department or its agents.

(10) It shall be lawful for any person licensed pursuant to section 29.343 (3), Wis. Stats., to use a trammel net not more than 300 feet in length and with a mesh of any size for the taking of fish as set forth in section NR 22.09. Such trammel nets may be used throughout the year in that part of the Mississippi river between the states of Wisconsin and Iowa under the jurisdiction of the state of Wisconsin which lies within the navigation channel as established by the United States war department; in Twelve Mile (Cassville) slough, State Line slough and Hurricane Chute in Grant county. Such trammel nets may be used in a drifting manner only. It shall be unlawful for any person to use or operate any trammel net in any manner except as provided in this section.

(11) No net or nets of any kind or setlines shall be lifted, hauled or drawn in any manner between one-half hour after sunset and one hour before sunrise of the following morning, except for the purpose of completing a seine haul with the permission of the supervisor nor shall any net, except a trammel net, be used in a drifting manner.

(12) All fishermen licensed under the provisions of sections 29.34, 29.37 and 29.343, Wis. Stats., shall report to the department on blanks to be furnished by the department, detailed information regarding their activities which shall include the number of pounds and varieties of fish taken, amounts returned to the water and any other information pertaining to commercial fishing activities required by the department.

(13) No licensed commercial fisherman or any member of his crew or any person in his boat shall have in his possession any panfish or game fish or sport angling equipment while operating licensed commercial gear, including setlines, or while traveling to or from the operation of such gear.

**NR 22.10 Boundary, commercial fishing.** For the purpose of clamming, setline and commercial net fishing, the Mississippi river shall be designated as that part of the river following the boundaries between the states of Wisconsin and Iowa.

**NR 22.11 Reciprocity, hook and line fishing.** All residents of Wisconsin and Iowa holding a resident hook and line fishing license

from their respective states, or residents of states other than Wisconsin and Iowa holding a hook and line fishing license issued by either state may fish in any of the waters lying between the Chicago, Milwaukee and St. Paul railway tracks on the Iowa side of the river and the Chicago, Burlington and Quincy railway tracks lying on the Wisconsin side of the river during the open season for hook and line fishing. This reciprocity does not apply to clambers or commercial gear operators.

**NR 23.02 Seasons; limits.** There are provided and established the following open and closed seasons, bag limits, size limits, possession limits and other fishing regulations for the several varieties and species of fish in the waters herein designated. A closed season is established for each variety of fish named herein extending during all the item of the year except the open season period embraced within the specified dates, both inclusive, and except as otherwise expressly provided, no person or persons shall take, catch or kill fish of any variety, or fish by any means other than with hook and line; nor at any time other than the open season therefor; nor have in his possession or under his control any fish in excess of the daily creel or possession limit, or fish of less than the legal minimum size during the open season.

**NR 23.03 Hook and line fishing.** (1) It shall be unlawful for any person to use or operate more than 2 lines or 2 poles with one line attached to each pole, and with an aggregate total not to exceed 4 hooks or to leave any fish line or lines unattended in any waters or to take any fish by snagging or fouling in any manner. Unless otherwise provided, any such fish taken other than in the mouth by snagging or fouling must immediately be returned to the water.

(2) It shall be unlawful for any person to take, capture, or kill fish or fish for fish of any variety at any time in Lac Vieux Desert, Mamie, West Bay, Big and Tenderfoot lakes from a motor-driven boat when the motor is running or from any boat in tow of a motor-driven boat when the motor is running or from any sailboat when in motion.

(3) It shall be unlawful for any person to take, catch, or kill fish, or fish for fish of any variety during the closed season for trout in streams and creeks containing trout. For the purpose of this rule the Montreal river upstream from the power dam in section 15, township 48 north, range 49 west, Gogebic county, Michigan, and section 7, township 47 north, range 1 east, Iron county, Wisconsin, and that portion of the Brule river upstream from U. S. highway #2 bridge in section 9, township 41 north, range 32 west, Iron county, Michigan, and in section 12, township 40 north, range 17 east, Florence county, Wisconsin, shall be considered trout waters.

**NR 23.04 Fishing near dams.** It shall be unlawful for any person to take, catch, or kill fish by any means other than with hook and line within 200 feet below any dam.

**NR 23.05 Spears.** (1) It shall be unlawful for any person to have in his possession or under his control from 8:00 p.m. to 6:00 a.m., central standard time, on any waters specified herein, except as otherwise provided herein, any spear, similar device or bow and arrow that might be used to take, catch or kill fish, or at any time on any waters containing trout or in which trout have been planted.

(2) Northern pike or pickerel, but no other species of fish, may be taken by means of spears through the ice from January 1 to February 15, inclusive, from 6:00 a.m. to 8:00 p.m., central standard time, subject to the bag, possession and size limits prescribed for northern pike.

(3) Suckers, redhorse, carp, buffalo fish, dogfish, garpike, sheepshead, smelt and burbot may be taken by means of spears from 6:00 a.m. to 8:00 p.m., central standard time, only from May 1 to May 31, inclusive, in the waters of Menominee river above the Nathan Bridge.

(4) Cisco and whitefish may be taken by means of spears from October 15 to December 31, inclusive of each year, in the waters of Smoky lake. Such spearing may be done in either the daytime or at night and with the aid of artificial lights.

**NR 23.06 Dip nets.** (1) Dip nets may be used for taking suckers, redhorse, carp, buffalo fish, dogfish, garpike, sheepshead, smelt and lawyers or burbot from April 1 to May 14, inclusive, in the Menominee river, except that it shall be unlawful to use any dip net in that part of the Menominee river beginning at the upstream side of the Hattie Street Bridge in Marinette-Menominee and extending upstream to the first dam and within 200 feet below all other dams.

(2) Such dip nets used for taking, catching, and killing rough fish and smelt shall be defined as follows:

A piece of netting suspended from a square or round frame not exceeding 9 feet square or 9 feet in diameter making a bag when lifted not more than 4 feet deep.

(3) It shall be unlawful for any person to use or operate any dip net in any manner other than by raising and lowering vertically when fishing.

**NR 23.07 Ice fishing.** (2) **FISH SHANTIES.** Buildings, vehicles, tents, fish shanties or similar enclosures may be used on the ice for fishing purposes in the waters specified in this chapter. The door of any such enclosure or shelter shall be readily opened from the outside at all times while enclosure or shelter is occupied. All such shelters shall be removed from the ice on or before March 15 each year on all waters listed in this chapter, or previous to that time by the order of the department or by its agents when they feel that the ice has become unsafe for travel thereon.

(3) **NAME OF OWNER.** All buildings, tents, fish shanties and similar enclosures or shelters maintained, occupied, or used for fishing purposes on the ice of any inland boundary waters shall have the name and address of the person owning or using the same painted on the outside thereof in such manner as to be readily visible at all times.

**NR 23.08 Reciprocity.** All residents of Wisconsin and Michigan holding a resident fishing license from their respective states, or residents of states other than Wisconsin and Michigan holding an angling license issued by either state, may fish in any of the waters listed in section NR 23.01. This reciprocity applies only to hook and line fishing and the taking of minnows and smelt by means of dipnets, but minnows so taken shall not be sold, traded or bartered.
