S-L 2.01 Articles of incorporation. Pursuant to the provisions of

section 215.41 (1), Wis. Stats., the savings and loan commissioner and the savings and loan advisory committee approve the following form of articles of incorporation for savings and loan associations organized under chapter 215, Wis. Stats.: ARTICLES OF INCORPORATION OF ASSOCIATION Wisconsin KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned adult citizens of the State of Wisconsin, do hereby make, sign and agree to the following: ARTICLES OF INCORPORATION ARTICLE FIRST. All powers, privileges, rights and duties granted or imposed by the Statutes of Wisconsin, and Acts amendatory thereof and supplemental thereto, now or hereafter in effect, shall be deemed to be a part of these Articles of Incorporation as though fully stated herein. ARTICLE SECOND. The undersigned have associated themselves together for the purpose of incorporating a savings and loan association pursuant to Chapter 215, of the Statutes of Wisconsin, and Acts amendatory thereof and supplemental thereto. The purpose and business of the association shall be the raising of money to be loaned to its members in accordance with said Chapter 215 and the Bylaws of the association. ARTICLE THIRD. The name of the association shall be _____ Association. ARTICLE FOURTH. The location of the association shall be in the City of , in the County of _____, State of Wisconsin.

- ARTICLE FIFTH. The capital of the association is unlimited and shall be governed by Chapter 215, Statutes of Wisconsin, and Acts amendatory threof and supplemental thereto.
- ARTICLE SIXTH. Membership in the association shall be obtained and terminated in the manner prescribed by Chapter 215, Statutes of Wisconsin, and Acts amendatory thereof and supplemental thereto, and the Bylaws of the association.
- ARTICLE SEVENTH. The government and general management of the association shall be vested in a board of directors to be elected in accordance with the Bylaws. The board of directors shall consist of such number as designated in the Bylaws.
- ARTICLE EIGHTH. The general officers of the association and their election shall be governed by the Bylaws of the association.

ARTICLE NINTH. These Articles of Incorporation may be amended in accordance with the provisions of Chapter 215, Statutes of Wisconsin, and Acts amendatory thereof and supplemental thereto.

ARTICLE TENTH. Dissolution of the association shall be accomplished in accordance with the provisions of Chapter 251, Statutes of Wisconsin, and Acts amendatory thereof and supplemental thereto.
