Ins 7.01 Forms

Ins 7.01 Forms. Annual statements of financial condition and other requirements shall be furnished by insurers to the commissioner of insurance.

- (1) **EXHIBITS.** (a) Accident and health policy experience
- (b) Assessment life and accident insurance companies
- (c) Credit life and accident and health exhibit
- (d) Fire and casualty companies
- (e) Fraternal benefit societies
- (f) Hospital service and medical indemnity corporations
- (g) Insurance expense exhibit
- (h) Life and accident and health insurance companies
- (i) Title and mortgage guaranty companies
- (j) Town mutual annual statement
- (2) **MISCELLANEOUS.** (a) Schedule of fees and taxes—fire and casualty insurers.
- (b) Annual application for license—fire and casualty insurers.
- (c) Appointment of general or state agent.
- (d) Exhibit of insurance in force—mutual fire insurance companies.
- (e) Risks in force; recapitulation of risks and premiums and unearned premiums; and assessment schedule—domestic mutual hail and cyclone insurers.
- (f) Reinsurance accepted and ceded schedule (Wisconsin business only).
- (g) Schedule 18S (bonds of officers and employes and system of auditing) and Schedule 24S (report of agents' commissions).

(x) Certificates by banks of deposits of and indebtedness of insurance companies.

(y) Wisconsin cities, villages, and towns entitled to fire department dues.

(z) Resolution and agreement re: disabled persons (casualty insurance).

(z-1) Deviations from actuarial bureau rates and rules—fire and allied lines insurers.

(3) APPLICATIONS FOR: (a) adjusters' licenses.

(b) resident life insurance agents.

(c) nonresident life insurance agents.

(d) fire insurance agents.

(e) casualty insurance agents.
