H 106.01 Qualification requirements for H 106.02 Qualification requirements for medical health officers

H 106.01 Qualification requirements for non-medical health officers. To be eligible for appointment an applicant for non-medical health officer as required by ss. 140.09 (4), 141.015 (13) and 141.02 (2), Stats., shall meet the training and experience requirements of sub. (1), (2), or (3):

(1)Graduation from an approved college or university operating a school of public health approved by the state health officer with a major in public health which resulted in the acquiring of a degree of bachelor of science in public health followed by at least 2 years of closely supervised experience in public health practice approved by the state health officer, such experience having been acquired in the employ of an official federal, state or local public health agency.

(2) Graduation from an approved college or university and successful completion of one additional academic year of training in a school of public health approved by the state health officer followed by at least 2 years of closely supervised experience in public health practice, approved by the state health officer, such experience having been acquired in the employ of an official federal, state or local public health agency.

(3) Have completed within 3 years following appointment one year of academic training in a school of public health approved by the state health officer; have at least 10 years of experience in public health practice approved by the state health officer, such experience having been acquired in the employ of an official federal, state or local public health agency; and pass an examination on public health administration given by the state board of health.

H 106.02 Qualification requirements for medical health officers. To be eligible for appointment an applicant for medical health officer as required by s. 140.09 (4), Stats., shall meet the training and experience requirements of subs. (1) and either (2) or (3):

(1) Graduation with a degree of doctor of medicine from a medical school of recognized standing, satisfactory completion of an internship of at least one year in an approved hospital, license or eligibility for medical licensure in Wisconsin.

(2) Successful completion of at least one academic year of training in a school of public health approved by the state health officer plus at least 12 months of closely supervised practical experience in general public health practice approved by the state health officer. The 12 months of closely supervised practical experience may be met during the first 12

months following appointment if the applicant and his employing board of health sign an agreement that the appointee will for the ensuing 12month period be under the supervision of a district health officer or other public health physician designated by the state health officer.

(3) Successful completion of at least one semester or 2 quarters of training in a school of public health approved by the state health officer plus 3 years of closely supervised experience in public health practice approved by the state health officer, such experience having been acquired in the employ of an official federal, state or local public health agency.
