





(1) WAUSHARA COUNTY. (a) *Greenwood*. Township 19 north, range 8 east, town of Hancock.



NR 10.01 (3) (e), trapping by permit in the area described in sub. (5), and except for the retrieval of legally killed or crippled game in posted retrieval zones.



(2) DOUGLAS COUNTY. (a) *Brule river*. Township 49 north, range 10 west, town of Cloverland.




(3) JACKSON COUNTY. (a) *Dike 17*. Township 21 north, range 2 west, town of Millston.




(4) JUNEAU COUNTY. (a) *Meadow Valley*. Township 20 north, range 2 east, town of Kingston.




(b) *Necedah*. Township 18 north, range 3 east, town of Necedah.




(5) KENOSHA COUNTY. (a) *Bong*. Township 2 north, range 20 east, town of Brighton.






