

(19) Winnebago county. (a) U.W. - Oshkosh. Township 17 north, range 16 east, town of Black Wolf.



(b) Winnebago State Hospital. Township 19 north, range 17 east, town of Oshkosh.







(1) Adams county. (a) $Amy\ pond$. Township 14 north, range 7 east, town of New Haven.




(2) Burnett county. (a) $Crex\ Meadows$. Township 39 north, range 18 west, town of West Marshland.





(3) COLUMBIA COUNTY. (a) $Pine\ Island$. Township 12 north, range 8 east, town of Caledonia.




(4) Waukesha county. (a) Big Muskego Lake. Township 5 north, range 20 east, town of Muskego.

NR 15.022 No entry wildlife refuge except gun deer (Sept. 1 - Dec. 31) A wildlife refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time, or enter such areas for any reason from September 1 through December 31 unless such areas are posted open with department signs except to hunt deer during the open season for hunting deer established in ss. NR 10.01 (3) (e) and 10.117, trapping by permit in the area described in sub. (5), and except for the retrieval of legally killed or crippled game in posted retrieval zones.
