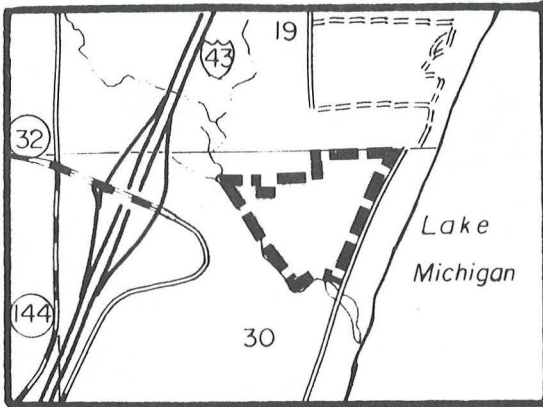
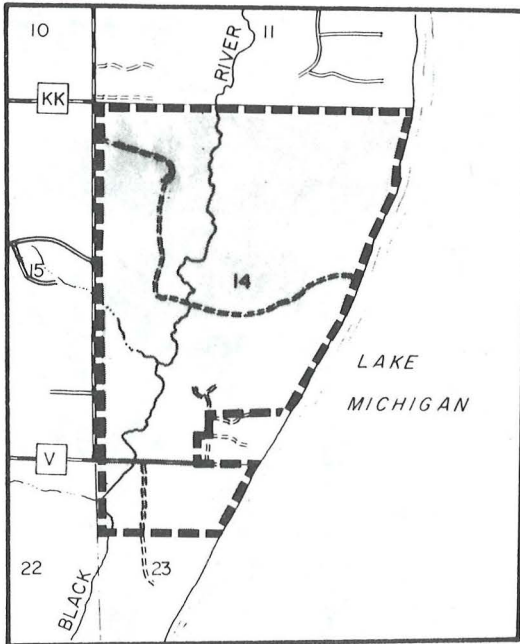


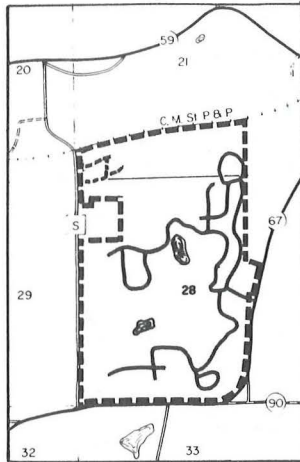
(16) SHEBOYGAN COUNTY. (a) Cedar Grove. Township 13 north, range 23 east, town of Holland.



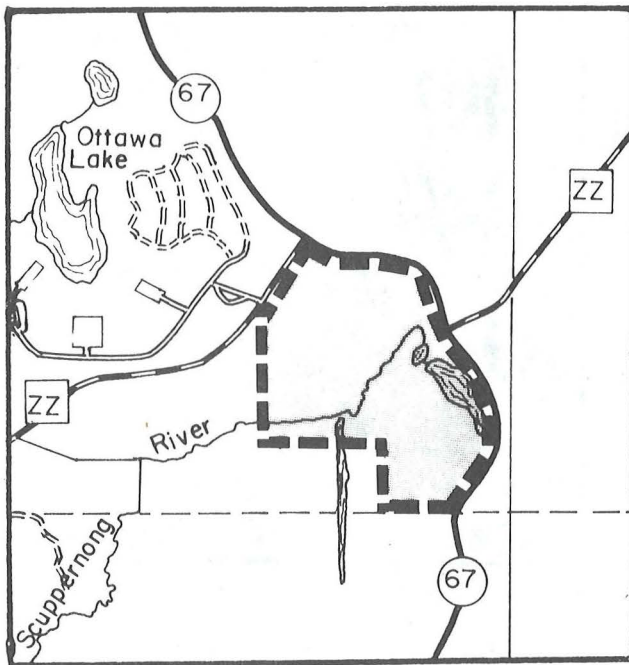
(b) Forest preserve. Township 14 north, range 23 east, town of Wilson.



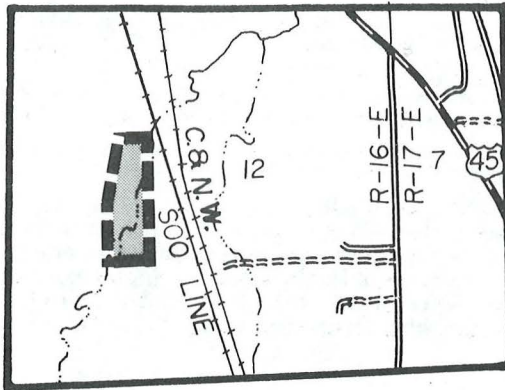
(17) WAUKESHA COUNTY. (c) *Old World Wisconsin*. Township 5 north, range 17 east, town of Eagle.



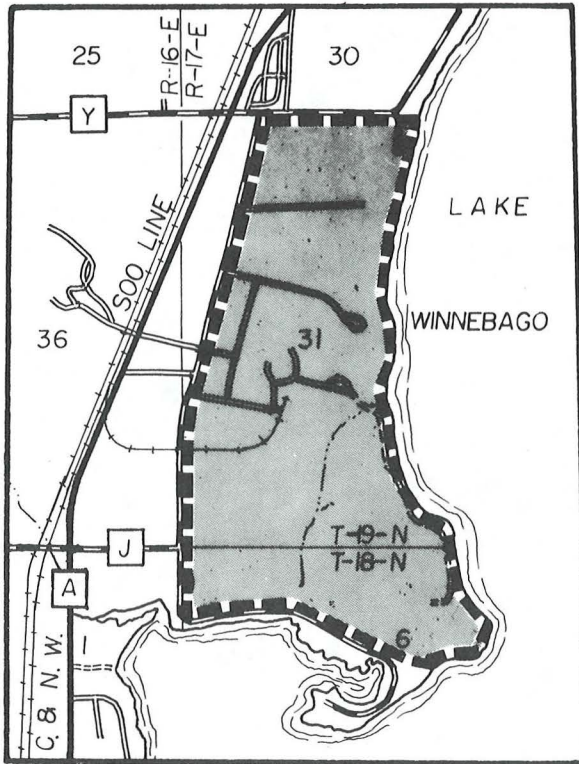
(b) *Scuppernong Springs Nature Area*. Township 6 north, range 17 east, town of Ottawa.

NR 15.02 No entry wildlife refuge (Sept. 1 - Dec. 31). A wildlife refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time, or enter such areas except for the retrieval of legally killed or crippled game in posted retrieval zones from September 1 through December 31 unless such areas are posted as open with department signs.
