WCD 11.01 Complete protection. It shall be unlawful for any person to take, catch, kill, hunt, trap, or pursue in any manner any species of wild animals or birds at any time on the following described areas:

(1) CHIPPEWA COUNTY. (a) *Fisher river.*

Township 31 north, range 6 west, towns of Estella and Holcombe.

Section 4—All that part lying west and south of town road running diagonally through SW SW of said section.

Section 5—All that part lying south of town road running generally east and west through said section.

Section 6—All that part lying south and east of the Chippewa river and south of a straight east-west line extending from the west end of the town road described in section 5 to the east bank of the Chippewa river.

Section 7—All that part lying east of a line formed by the Chippewa river and the Brunet Island park road including the mouth of the Fisher river.

Section 8—Entire section.

Section 9—All that part lying north and west of town road running diagonally through NW¼ of said section.

WCD 11.02 Closed area; waterfowl project. It shall be unlawful for any person to take, catch, kill, hunt or pursue with the use of firearms or bow and arrow any species of wild animals or birds at any time on the following described areas:

(1) BROWN COUNTY. (a) *Preble*.

Townships 23 and 24 north, range 21 east, town of Preble.

All that part of township lying westerly of a line beginning at a point where the south boundary of said township intersects county highway "V", thence northerly and easterly along said highway "V" to the east line of section 4, thence northerly along the east line of said section to a point 80 rods south of the northeast corner of section 4, thence easterly in a straight line to Baird's Creek road, thence northerly along Baird's Creek road to its junction with county highway "N", thence westerly along said highway "N" to its junction with state highways 54 and 57, thence westerly along said highways 54 and 57 to its junction with the north-south center line of sections 33 and 28, thence northerly along said center line to its junction with the shore line of Green Bay.

WCD 11.04 Closed area; deer. It shall be unlawful for any person to take, catch, kill, hunt, or pursue with the use of any rifle other than a .22 rim fire, shotguns loaded with single slug or ball, or bow and arrow any species of wild animals or birds at any time on the following described areas:

(1) ASHLAND COUNTY. (a) *La Pointe*.

Township 50 north, range 3 west, Madeline island.

All that part of section 30 bounded by the following description: Beginning at a point on the lake shore 200 yards south of the La Pointe ferry dock and opposite the point where the southern route of county highway "H" turns ENE and proceeding for 250 yards on county highway "H" to a town road; proceed north on said town road to its junction with the northern route of county highway "H"; thence in a southwesterly direction on county highway "H" for a distance of 340 yards to the junction of a town road; proceed due north on said town road until directly east of Pt. DeFroid; proceed west from this point on a town road to the lake shore; thence southerly along lake shore to point of beginning.
