Opt 6.01 Authority. The rules in this chapter are adopted under authority in ss. 15.08 (5) (b), 227.11 (2) and 449.18, Stats.

Opt 6.02 Definitions. (1) "Adverse drug reaction referral plan" has the meaning given under s. RL 10.01.

(2) "Biennium" means a 2 year period beginning January 1 of even-numbered years.

(3) "Board" means the optometry examining board.

(4) "100 hours of approved study" means a course of study offered on or after January 1, 1987 by an institution approved by the board in accordance with s. 449.18, Stats.

(5) "TPA certificate" means a certificate granted by the optometry examining board as defined in s. RL 10.01.

(6) "TPA" or "therapeutic pharmaceutical agent" means the agents as defined in s. RL 10.01.

Opt 6.03 Application for certification. To obtain a TPA certificate an optometrist shall:

(1) Submit evidence satisfactory to the board that the optometrist has complied with the following requirements in accordance with s. 449.18, Stats.:

(a) Has obtained certification under s. 449.17, Stats., to use DPA's;

(b) Has successfully completed 100 hours of approved study in the use of TPA's and removal of superficial foreign bodies from an eye or from an appendage to the eye; and

(c) Has passed an examination conducted or approved by the board.

(2) Submit an updated adverse drug reaction referral plan revised to reflect planning for use of therapeutic pharmaceutical agents.

Note: 100 hours postgraduate courses and qualifying examinations for approval for TPA certification are approved annually by the board. A list of approved 100 hours postgraduate courses and examinations may be obtained from the board office at P.O. Box 8935, Madison, Wisconsin 53708.

Opt 6.04 Continuing education. (1) (a) Except as provided in par. (b), a certificate holder shall complete 30 hours of approved continuing education relating to diagnosis and management of eye disease in each biennial registration period. Seven of the 30 hours must be in the diagnosis and management of glaucoma, and 2 of the 30 hours must relate to the responsible use of controlled substances and substance abuse concerns, new drugs used for ophthalmic therapeutic purposes which have been approved by the federal food and drug administration or other topics as designated by the board.

(b) During the biennium renewal registration period beginning on January 1, 1994, and ending on December 31, 1995, a certificate holder as specified in s. Opt 6.02 (4) shall complete 30 hours of approved continuing education relating to the diagnosis and management of eye disease. Seven of the 30 hours must be in the diagnosis and management of glaucoma, and 1 of the 30 hours

must relate to the responsible use of controlled substances and substance abuse concerns, new drugs used for ophthalmic therapeutic purposes which have been approved by the federal food and drug administration or other topics as designated by the board.

Note: A list of approved topics designated by the board for purposes of satisfying the 2 hour course requirement under this section may be obtained from the board at P.O. Box 8935, Madison, Wisconsin 53708.

(2) Continuing education hours may be applied only to the biennial registration period in which the continuing education hours are acquired, except as provided under s. Opt 6.08, to apply credits to the previous biennium to satisfy requirements for reinstatement of a certificate which has lapsed.

(3) To obtain credit for completion of continuing education hours, an optometrist shall submit to the board certificates of attendance from the provider of the board-approved course.

(4) A TPA certificate holder who fails to meet the continuing education requirements by the renewal deadline may not use therapeutic pharmaceuticals or remove superficial foreign bodies from the eye or from an appendage to the eye after the renewal deadline until the certificate is reinstated under s. Opt 6.08.

(5) Optometrists initially certified under s. 449.18, Stats., within a biennium shall submit to the board proof of completion of one hour of board approved continuing education per month or partial month of certification reported on or before January 1 of the biennium. A minimum of one-quarter of the continuing education hours must be in the diagnosis and management of glaucoma.

Opt 6.05 Approval of continuing education courses.

(1) Except as provided in sub. (6), to apply for approval of a continuing education course, a course provider shall submit to the board office an application on forms provided by the board and shall include the title, general description and an outline of the course, the dates, the location, the name and qualifications of the instructor of the course, and the sponsor of the course.

(2) The following criteria will be considered in the approval process:

(a) The subject matter of the course pertains to therapeutic pharmaceuticals and removal of superficial foreign bodies from the eye or from an appendage to the eye, or to diagnosis and management of eye disease;

(b) The provider of the continuing education course agrees to monitor the attendance and furnish to each participant a certificate of attendance;

(c) The provider of the course is approved by the board; and

(d) The course content and instructional methodologies.

(3) Except as provided in sub. (6), a separate application shall be submitted for each continuing education course approval request.

(4) If a continuing education course includes subject matter other than that related to diagnosis and management of eye disease and removal of superficial foreign bodies from the eye or from an

appendage to the eye, only the board-approved portions of the course which relate to diagnosis and management of eye disease and removal of superficial foreign bodies from the eye or from an appendage to the eye qualify as continuing education required under this chapter.

(5) Alternate delivery method continuing education courses such as home-study courses, self-study packages, computer courses, televideo conferencing and other methods may be approved by the board.

(6) A continuing education course approved by the council on optometric practitioner education which satisfies the criteria established under sub. (2), may be approved by the board without receipt of a course approval application from the provider.

Opt 6.06 Renewal of certificate. TPA certificates expire on January 1 of each even-numbered year. Renewal applications shall be submitted on a form provided by the department on or before the renewal date specified in s. 440.08 (2) (a) 54., Stats., along with proof of completion of the continuing education requirements specified in s. Opt 6.04.

Opt 6.07 Failure to renew. An optometrist who fails to renew a TPA certificate by the renewal date may not use therapeutic pharmaceutical agents or remove foreign bodies from an eye or from an appendage to the eye until the certificate is restored under s. Opt 6.08.

Opt 6.08 Late renewal of certificate. An optometrist who fails to renew a TPA certificate by the renewal date may restore the TPA certificate by submitting an application on a form provided by the department, and satisfying the following requirements:

(1) If applying less than 5 years after the renewal date, submit proof of completion of 30 hours of continuing education coursework as required under s. Opt 6.04.

(2) If applying 5 years or more after the renewal date, submit proof of completion of 30 hours of continuing education coursework as required under s. Opt 6.04, and proof of:

(a) Successful completion of educational coursework required by the board to ensure protection of the public health, safety and welfare, and

(b) Successful completion of an examination required by the board to ensure protection of the public health, safety and welfare.
