


NR 11.01 Waterfowl closed area. A closed season is established in the following areas as posted with department signs. No person may hunt or trap any species of wild animal thereon during the open seasons on waterfowl established in s. NR 10.01. Legally killed or crippled game may be retrieved by dog or hand.

NR 11.011 Waterfowl closed area: disturbance prohibited. A closed season is established in the following areas posted with department signs. No person may hunt or trap any species of wild animal or disturb waterfowl thereon during the open seasons on waterfowl established in s. NR 10.01(1)(b) and (g) and from the day following the close of said waterfowl seasons through December 31. Legally killed or crippled game may be retrieved by dog or hand.







No person may hunt or trap any species of wild animal thereon, except Canada geese on areas and during periods established in s. NR 10.23, and deer during periods established in s. NR 10.01 (3) (e) and (es), during the open seasons on waterfowl established in s. NR 10.01 (1). Legally killed or crippled game may be retrieved from such areas by dog or hand.






(3) DODGE COUNTY. (a) *Burnett Ditch*. Township 12 north, range 15 east, town of Burnett.





NR 11.032 Mississippi river closed area. A closed season is established in the following areas which are posted with U.S. fish and wildlife service signs. No person may hunt or trap any species of wild animal at any time except that hunting or trapping is allowed for all species but ducks and geese during the seasons established in s. NR 10.01, but only from the day after the final closure of the duck season as established in s. NR 10.01 (1) (b), until June 15. Legally killed or crippled game may be retrieved from these areas by dog or hand.



No person may hunt or trap any species of wild animal thereon, except deer during periods established in s. NR 10.01 (3) (e) and (es), during the open season on waterfowl established in s. NR 10.01 (1) (b) and (g). Legally killed or crippled game may be retrieved from such areas by dog or hand.

NR 11.042 Waterfowl closed area; trapping and deer hunting permitted.

A closed season is established in the following areas posted with department signs. Trapping of furbearing mammals is permitted during established seasons. No person may hunt any species of wild animal, except deer during periods established in s. NR 10.01 (3) (e), (em) and (es), during the open season on waterfowl established in s. NR 10.01 (1) (b) and (g). Legally killed or crippled game may be retrieved by dog or hand.






NR 11.05 Migratory bird closed area; trapping permitted.

(1) ASHLAND, BAYFIELD AND SAWYER COUNTIES. (a) *Clam Lake.*



NR 11.12 State trail closed areas. A closed season is established on the following areas as posted with department signs. No person may hunt or trap any species of wild animal thereon beginning February 1 and continuing through the Friday preceding the Saturday nearest October 17, both dates inclusive.

NR 11.11 Deer closed area; trapping permitted. A closed season is established in the following areas posted with department signs. No person may hunt any species of wild animal thereon, except waterfowl during periods established in s. NR 10.01 (1), during the open gun deer season established in s. NR 10.01 (3) (e). In addition, a closed season is established for archery hunting of deer beginning the Saturday immediately following the close of gun deer season and continuing through December 31.

NR 11.13 Public lands closed area. The department may establish closed season areas by posting signs within the exterior limits of public hunting grounds, state wildlife areas and other state-owned or leased lands administered for wildlife management purposes. No person may hunt or trap any species of wild animals except as authorized by posted department signs posted on the lands.
