WCD 11.26 Closed area; waterfowl retrieving zone. It shall be unlawful for any person to have any firearm in his possession or under his control, unless such firearm is unloaded and enclosed within a carrying case, or to take, catch, kill, hunt, trap or pursue in any manner any species of wild animals or birds on the following described area, except deer during the open gun season, and except that legally killed or crippled waterfowl may be retrieved by dog or hand.
