No person may hunt or trap or have in his or her possession or under control within such area any firearm unless it is unloaded and completely enclosed within a carrying case, or any bow unless it is unstrung or completely enclosed within a carrying case, without authorization from the U.S. fish and wildlife service.

A wildlife refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time within such areas. No person may enter such areas for any reason from September 1 through December 31 unless such areas are posted as open with department signs except to hunt deer during the open gun and muzzleloader seasons for hunting deer established in ss. NR 10.01 (3) (e) and (es) and 10.117, trapping by permit in the area described in sub. (5), and except for the retrieval of legally killed or crippled game in posted retrieval zones.

NR 15.11 Horicon marsh fur farm. (1) A state fur farm to be known as the Horicon marsh fur farm is established on all of the state—owned lands on the Horicon marsh wildlife area in Dodge county as mapped and no person may hunt or trap any furbearing animals on such area unless authorized by a valid department permit. Any violation of the permit terms shall be deemed to be a violation of this section.



- (3) This section shall not prohibit the department or its fully authorized agents, the armed forces of the national guard or of the United States, or any peace officers or any person summoned by a peace officer to assist him in making an arrest or in preserving the peace from entering and being on the above described Horicon marsh fur farm in the performance of official duties.


