



**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 126**

March 29, 1995 – Offered by Representative Silbaugh.

1 **AN ACT** *to renumber and amend* 19.45 (12); *to amend* 13.10 (3) and 19.58 (1);
2 and *to create* 19.45 (12) (a) 1. and 2. and (b) of the statutes; **relating to:**
3 requests for increased appropriations to state agencies.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 13.10 (3) of the statutes is amended to read:

5 13.10 (3) All requests for action by the committee shall be filed with the
6 secretary of the committee in writing and shall contain a statement of the action
7 requested, the purposes therefor, the statutory provision authorizing or directing the
8 performance of the action, and such other information as the committee may require.
9 The governor shall submit a recommendation on the request to the committee. The
10 committee shall afford all such requests a public hearing and the secretary of the
11 committee shall give public notice of the time and place of such hearing. The
12 committee shall not act upon any request that is submitted in violation of s. 19.45
13 (12).

1 **SECTION 2.** 19.45 (12) of the statutes is renumbered 19.45 (12) (a) (intro.) and
2 amended to read:

3 19.45 **(12)** (a) (intro.) No agency, as defined in s. 16.52 (7), ~~or officer or~~ any
4 employe thereof may present any request, or knowingly utilize any interests outside
5 the agency to present any request, to either house of the legislature or to any member
6 or committee thereof, for appropriations which exceed the amount requested by the
7 agency in the agency's most recent request submitted under s. 16.42~~7~~, except as
8 follows:

9 **SECTION 3.** 19.45 (12) (a) 1. and 2. and (b) of the statutes are created to read:

10 19.45 **(12)** (a) 1. An employe of such an agency may seek additional
11 appropriations for the agency upon receiving written approval from the governor or
12 the secretary of administration.

13 2. An employe of such an agency may seek additional appropriations for the
14 agency while acting in his or her capacity as a private citizen, if the request is made
15 while the employe is not engaged in official duties.

16 (b) An officer of an agency under par. (a) who is not an employe of the agency
17 may present any request to either house of the legislature or to any member or
18 committee thereof.

19 **SECTION 4.** 19.58 (1) of the statutes is amended to read:

20 19.58 **(1)** Any person who intentionally violates any provision of this
21 subchapter, except s. 19.45 (12), or a any code of ethics adopted or established under
22 s. 19.45 (11) (a) or (b) shall be fined not less than \$100 nor more than \$5,000 or
23 imprisoned for not more than one year in the county jail or both.
