ASSEMBLY AMENDMENT 28, TO 1995 ASSEMBLY BILL 130

May 24, 1995 - Offered by Representatives Huber, Murat and Cullen.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 89, line 5: on lines 5 to 9, delete the underscored material and restore the stricken material.
 - **2.** Page 89, line 15: delete "15" and substitute "10".
- **3.** Page 89, line 16: delete "transferred to the criminal courts" and substitute: "transferred to the criminal courts subject to the jurisdiction of the court of criminal jurisdiction".
- 5 **4.** Page 90, line 21: delete lines 21 to 23.
- **5.** Page 91, line 1: delete lines 1 to 10 and substitute:
- 7 **"Section 328m.** 48.44 (1) of the statutes is renumbered 48.44.".

 - **21.** Page 196, line 7: after that period insert: "For a juvenile 17 years of age or over who has contested a petition for waiver initiated by the district attorney or court, the court shall enter an order waiving jurisdiction and referring the matter to the district attorney for appropriate proceedings in the court of criminal jurisdiction, and the court of criminal jurisdiction thereafter has exclusive jurisdiction, unless the court determines on the record that the juvenile has established by clear and convincing evidence that it would be in the best interests of the juvenile or of the

public for the court assigned to exercise jurisdiction under this chapter and ch. 48 to hear the case.".
