## SENATE AMENDMENT 10, TO SENATE SUBSTITUTE AMENDMENT 1, TO 1995 ASSEMBLY BILL 130

September 21, 1995 – Offered by Senator MOORE.

1	At the locations indicated, amend the substitute amendment as follows:
2	<b>1.</b> Page 6, line 9: after "authority" insert ", making an appropriation".
3	<b>2.</b> Page 17, line 8: after that line insert:
4	"SECTION 29m. 46.263 (1) of the statutes, as affected by 1995 Wisconsin Act 27,
5	section 2206g, is amended to read:
6	46.263 (1) From the appropriation under s. $20.435$ (3) (f), the department shall
7	distribute $3,750,000$ $5,000,000$ in each year to counties for early intervention
8	services for first offenders and for intensive community-based intervention services
9	for seriously chronic offenders.
10	<b>SECTION 29p.</b> 46.263 (1) of the statutes, as affected by 1995 Wisconsin Acts 27
11	and (this act), is repealed.".
12	<b>3.</b> Page 142, line 25: after that line insert:
13	"SECTION 551m. 301.263 (1) of the statutes, as created by 1995 Wisconsin Act
14	27, is amended to read:

1	301.263 (1) From the appropriation under s. 20.410 (3) (f), the department
2	shall distribute \$3,750,000 <u>\$5,000,000</u> in each year to counties for early intervention
3	services for first offenders and for intensive community-based intervention services
4	for seriously chronic offenders.".
5	<b>4.</b> Page 412, line 12: after that line insert:
6	"SECTION 9212. Appropriation changes; corrections.
7	(1g) COMMUNITY INTERVENTION PROGRAM. In the schedule under section 20.005
8	(3) of the statutes for the appropriation to the department of corrections under
9	section 20.410 (3) (f) of the statutes, as affected by the acts of 1995, the dollar amount
10	is increased by \$1,250,000 for fiscal year 1996-97 to increase funding for the
11	purposes for which the appropriation is made.".
12	<b>5.</b> Page 412, line 12: after that line insert:
13	"SECTION 9226. Appropriation changes; health and social services.
14	(1g) COMMUNITY INTERVENTION PROGRAM. In the schedule under section 20.005
15	(3) of the statutes for the appropriation to the department of health and social
16	services under section 20.435 (3) (f) of the statutes, as affected by the acts of 1995,
17	the dollar amount is increased by \$1,250,000 for fiscal year 1995–96 to increase
18	funding for the purposes for which the appropriation is made.".
19	<b>6.</b> Page 414, line 16: after that line insert:
20	" $(3g)$ Community intervention program. The amendment of section 46.263 (1)
21	of the statutes and SECTION 9226 (1g) of this act take effect on January 1, 1996, or
22	on the day after publication, whichever is later.".
