



**SENATE AMENDMENT 100,
TO 1995 ASSEMBLY BILL 150**

June 27, 1995 – Offered by Senators MOORE, RISSER and GEORGE.

1 At the locations indicated, amend the engrossed bill as follows:

2 **1.** [Page 276, line 9](#): increase the dollar amount for fiscal year 1995–96 by
\$15,800 for the purpose of increasing the authorized FTE positions for the
department of health and social services by 0.38 GPR position for the purpose of the
food stamp outreach program.

3 **2.** [Page 277, line 7](#): after that line insert:

4 “(dq) Food stamp outreach GPR A 100,000 –0–”.

5 **3.** [Page 290, line 15](#): increase the dollar amount for fiscal year 1996–97 by
\$15,800 for the purpose of increasing the authorized FTE positions for the
department of industry, labor and human relations by 0.38 GPR position for the
purpose of the food stamp outreach program.

6 **4.** [Page 291, line 13](#): after that line insert:

7 “(dq) Food stamp outreach GPR A –0– 100,000”.

8 **5.** [Page 451, line 25](#): delete that line and substitute:

1 **“SECTION 860b.** 20.435 (4) (dq) of the statutes is renumbered 20.445 (3) (dq) and
2 amended to read:

3 20.435 (4) (dq) *Food stamp outreach.* The amounts in the schedule for food
4 stamp outreach under s. ~~46.74~~ 49.126.”.

5 **6.** Page 806, line 22: delete that line and substitute:

6 **“SECTION 2327b.** 46.74 of the statutes is renumbered 49.126, and 49.126 (2)
7 and (3), as renumbered, are amended to read:

8 49.126 (2) ~~Beginning in fiscal year 1994-95, from~~ From the appropriations
9 under s. ~~20.435 (4)~~ 20.445 (3) (dq) and (nL), the department shall distribute funds
10 to nonprofit organizations for projects that qualify for reimbursement under 7 USC
11 2025 (a) (4) to inform individuals with low incomes about the availability, eligibility
12 requirements, application procedures and benefits of the food stamp program.

13 **(3)** ~~From the appropriations under s. 20.435 (4)~~ 20.445 (3) (dq) and (nL), the
14 department shall distribute not more than \$10,000 in fiscal year 1993-94 to a
15 nonprofit organization to develop informational materials to be used by the projects
16 under sub. (2).”.

17 **7.** Page 2576, line 2: after that line insert:

18 “(33x) FOOD STAMP OUTREACH. The authorized FTE positions for the
19 department of health and social services are increased by 0.37 FED position on July
20 1, 1995, to be funded from the appropriation under section 20.435 (4) (n) of the
21 statutes, for the purpose of the food stamp outreach program.”.

22 **8.** Page 2703, line 22: after “(dn),” insert “(dq),”.

23 **9.** Page 2704, line 11: after “46.45 (intro.),” insert “46.74,”.
