



**ASSEMBLY AMENDMENT 1,
TO SENATE AMENDMENT 116,
TO 1995 ASSEMBLY BILL 150**

June 29, 1995 – Offered by Representatives PROSSER and BRANCEL.

1 At the locations indicated, amend the amendment as follows:

2 **1. Page 5, line 13:** after that line insert:

3 “36e. Page 134, line 23: after “moneys” insert “, if required by law,”.

4 36m. Page 135, line 1: delete “Each” and substitute “Subject to appropriations
5 as provided in sub. (6), each”.

6 36s. Page 136, line 17: delete lines 17 and 18.”.

7 **2. Page 35, line 14:** after that line insert:

8 “272m. Page 1097, line 13: after that line insert:

9 “**SECTION 3337r.** 66.77 (3) (d) of the statutes is created to read:

10 66.77 (3) (d) If a county imposes an operating levy in any year that is less than
11 the amount allowable under this section, the operating levy limit otherwise
12 applicable under this section to the county in the next succeeding year is increased
13 by an amount equal to 75% of the difference between the county’s allowable operating
14 levy as calculated under sub. (2m) in the previous year and the county’s operating
15 levy in that year.”.”.

1 **3. Page 36, line 8:** after that line insert:

2 “276d. Page 1099, line 17: after “moneys” insert “, if required by law,”.

3 276h. Page 1099, line 18: delete “, if required by law”.

4 276p. Page 1099, line 19: delete “Each” and substitute: “Subject to
5 appropriations as provided in sub. (6), each”.

6 276t. Page 1101, line 11: delete lines 11 and 12.”.

7 **4. Page 81, line 8:** after that line insert:

8 “538m. Page 2600, line 16: after that line insert:

9 “(3g) LEGISLATORS’ EXPENSES.

10 (a) Notwithstanding section 20.916 (8) of the statutes, beginning on the
11 effective date of this paragraph and ending on June 30, 1997, the speaker of the
12 assembly may adjust the maximum allowance for legislative expenses for
13 representatives to the assembly beginning on a specific date by filing a notice with
14 the chief clerk of the assembly to that effect, but only if the maximum allowance set
15 by the speaker of the assembly does not exceed the maximum allowance amount
16 approved by the joint committee on employment relations and if the speaker provides
17 at least 30 days’ written notice of the change to representatives of the assembly.
18 Notwithstanding section 20.916 (8) of the statutes, beginning on the effective date
19 of this paragraph and ending on June 30, 1997, the president of the senate may
20 adjust the maximum allowance for legislative expenses for senators beginning on a
21 specific date by filing a notice with the chief clerk of the senate to that effect, but only
22 if the maximum allowance set by the president of the senate does not exceed the
23 maximum allowance amount approved by the joint committee on employment

1 relations and if the president of the senate provides at least 30 days' written notice
2 of the change to senators.

3 (b) Notwithstanding section 13.123 (1) (a) 1. of the statutes, beginning on the
4 effective date of this paragraph and ending on June 30, 1997, if the speaker of the
5 assembly adjusts the maximum allowance under paragraph (a), a representative to
6 the assembly may not receive an allowance greater than the amount established by
7 the speaker of the assembly under paragraph (a). Notwithstanding section 13.123
8 (1) (a) 1. of the statutes, beginning on the effective date of this paragraph and ending
9 on June 30, 1997, if the president of the senate adjusts the maximum allowance
10 under paragraph (a), a senator may not receive an allowance greater than the
11 amount established by the president of the senate under paragraph (a).

12 (c) Notwithstanding section 13.123 (1) (a) 1. of the statutes, beginning on the
13 effective date of this paragraph and ending on June 30, 1997, a senator or
14 representative to the assembly may file a new affidavit under section 13.123 (1) (a)
15 1. of the statutes following any reduction of an allowance for members of his or her
16 house under this subsection which shall remain in effect until June 30, 1997.”.”.

17 538p. Page 2607, line 12: before “rules” insert “section 144.241 (8) (f) of the
18 statutes and”.

19 538q. [Page 2607, line 13](#): delete the material beginning with “amend” and
ending with the period on line 16, and substitute: “forgive the interest on \$480,000
of the clean water fund loan approved for the village of Wausaukee before the
effective date of this subsection.”.
