commission, but shall not exceed the lesser of the amount enumerated in the state building program for the project under general fund supported borrowing or 50% of the cost of constructing the center. The building commission may not make payments under this subsection, unless the department of administration has reviewed and approved the plans for the center. Notwithstanding sections 16.85 (1) and 16.855 (1) of the statutes, the department of administration shall not supervise any services or work or let any contract for the project. Sections 16.87 and 16.89 of the statutes do not apply to the project."
