



**SENATE AMENDMENT 42,  
TO 1995 ASSEMBLY BILL 150**

June 27, 1995 – Offered by Senator DECKER.

1 At the locations indicated, amend the engrossed bill as follows:

2 **1.** Page 480, line 17: after that line insert:

3 “**SECTION 1025m.** 20.455 (2) (r) of the statutes is renumbered 20.455 (2) (cm)  
4 and amended to read:

5 20.455 (2) (cm) *Gaming law enforcement; lottery revenues.* ~~From the lottery~~  
6 ~~fund, the~~ The amounts in the schedule for the performance of the department’s  
7 gaming law enforcement responsibilities as specified in s. 165.70 (3m).”.

8 **2.** Page 507, line 2: after that line insert:

9 “**SECTION 1119t.** 20.566 (8) (q) of the statutes, as created by 1995 Wisconsin Act  
10 .... (this act), is renumbered 20.566 (8) (a) and amended to read:

11 20.566 (8) (a) (title) *General program operations; lottery.* ~~From the lottery~~  
12 ~~fund, the~~ The amounts in the schedule for general program operations under ~~ch. 565~~  
13 chs. 561 to 569.

14 **SECTION 1119u.** 20.566 (8) (r) of the statutes, as affected by 1995 Wisconsin Act  
15 .... (this act), is renumbered 20.566 (8) (b) and amended to read:

1           20.566 (8) (b) *Retailer compensation*. ~~From the lottery fund, a~~ A sum sufficient  
2 to pay compensation to retailers under s. 565.10 (14) (b).

3           **SECTION 1119w.** 20.566 (8) (v) of the statutes, as affected by 1995 Wisconsin Act  
4 .... (this act), is renumbered 20.566 (8) (c) and amended to read:

5           20.566 (8) (c) *On-line vendor fees*. ~~From the lottery fund, a~~ A sum sufficient  
6 to pay vendors for on-line services and supplies provided by the vendors under  
7 contract under s. 565.25 (2) (a).”.

8           **3.** Page 560, line 23: after that line insert:

9           “**SECTION 1420ue.** 25.75 (1) (b) of the statutes is amended to read:

10           25.75 (1) (b) “Gross lottery revenues” means gross revenues from the sale of  
11 lottery tickets and lottery shares under ch. 565 and revenues from the imposition of  
12 fees, if any, under s. 565.10 (8) ~~and includes compensation, including bonuses, if any,~~  
13 ~~paid to retailers under s. 565.10 (14), regardless of whether the compensation is~~  
14 ~~deducted by the retailer prior to transmitting lottery ticket and lottery share~~  
15 ~~revenues to the commission.~~

16           **SECTION 1420um.** 25.75 (1) (c) (intro.) of the statutes is renumbered 25.75 (1)  
17 (c) and amended to read:

18           25.75 (1) (c) “Lottery proceeds” means the remainder of the gross lottery  
19 revenues after deducting ~~all of the following:~~ the amounts for prizes.

20           **SECTION 1420us.** 25.75 (1) (c) 2. and 3. of the statutes are repealed.”.

21           **4.** Page 561, line 3: after that line insert:

22           “**SECTION 1420vj.** 25.75 (3) (b) of the statutes, as affected by 1995 Wisconsin  
23 Act .... (this act), is repealed.”.

24           **5.** Page 1214, line 3: after that line insert:

1           **“SECTION 3510x.** 79.10 (11) (b) of the statutes is amended to read:

2           79.10 (11) (b) Before October 16, the department of administration shall  
3 determine the total funds available for distribution under the lottery credit in the  
4 following year and shall inform the joint committee on finance of that total. Total  
5 funds available for distribution shall be all existing and projected lottery proceeds  
6 and interest for the fiscal year of the distribution, less the amount estimated to be  
7 expended under ss. 20.455 (2) (~~r~~) (cm), 20.566 (2) (r) and 20.835 (2) (q) and (3) (r) and  
8 less the required reserve under s. 20.003 (5). The joint committee on finance may  
9 revise the total amount to be distributed if it does so at a meeting that takes place  
10 before November 1. If the joint committee on finance does not schedule a meeting  
11 to take place before November 1, the total determined by the department of  
12 administration shall be the total amount estimated to be distributed under the  
13 lottery credit in the following year.”.

14           **6.** [Page 2337, line 23](#): after that line insert:

15           **“SECTION 6981um.** 565.45 of the statutes, as affected by 1995 Wisconsin Act  
16 .... (this act), is repealed.”.

17           **7.** [Page 2701, line 1](#): after the last “(q)” insert “(by SECTION 1119r)”.

18           **8.** [Page 2701, line 12](#): after “565.45” insert “(by SECTION 6981u)”.

19           **9.** [Page 2701, line 14](#): after that line insert:

20           “(3z) LOTTERY CREDIT AND GAMING COMMISSION OPERATIONS, RETAILER  
21 COMPENSATION AND ON-LINE VENDOR FEES. The treatment of sections 20.455 (2) (r),  
22 20.566 (8) (q) (by SECTION 1119t), (r) and (v), 25.75 (1) (b) and (c) (intro.), 2. and 3.

1 and 79.10 (11) (b) of the statutes and the repeal of sections 25.75 (3) (b) and 565.45  
2 of the statutes take effect on July 1, 1997.”.
