SENATE AMENDMENT 93, TO 1995 ASSEMBLY BILL 150

June 27, 1995 - Offered by Senators RISSER and JAUCH.

1	At the locations indicated, amend the engrossed bill as follows:
2	1. Page 10, line 4: delete lines 4 to 17.
3	2. Page 42, line 3: delete lines 3 to 24 and substitute:
4	"SECTION 103w. 15.105 (8) of the statutes is amended to read:
5	15.105 (8) ARTS BOARD. There is created an arts board which is attached to the
6	department of administration tourism under s. 15.03. The arts board shall consist
7	of 15 members appointed for 3-year terms who are residents of this state and who
8	are known for their concern for the arts. At least 2 members shall be from the
9	northwest portion of this state, at least 2 members shall be from the northeast
10	portion of this state, at least 2 members shall be from the southwest portion of this
11	state and at least 2 members shall be from the southeast portion of this state.".
12	3. Page 49, line 5: delete the material beginning with that line and ending with
	page 50, line 21 and substitute:

1 15.447 **(1)** COUNCIL ON TOURISM. There is created in the department of development tourism a council on tourism consisting of 14 members serving 3-vear $\mathbf{2}$ 3 terms, and the secretary of development tourism or the secretary's designee, one 4 member of the majority party in each house and one member of the minority party $\mathbf{5}$ in each house appointed as are members of standing committees in their respective 6 houses, the executive secretary of the arts board and the director of the historical 7 society. Nominations for appointments to the council of members, other than ex 8 officio members, shall be sought from but not limited to multicounty regional 9 associations engaged in promoting tourism, statewide associations of businesses 10 related to tourism, area visitor and convention bureaus, arts organizations, 11 chambers of commerce, the Great Lakes inter-tribal council and other agencies or 12organizations with knowledge of American Indian tourism activities, and persons 13engaged in the lodging, restaurant, campground, amusement establishment, 14recreation establishment or retail liquor or fermented malt beverages business. 15Nominations shall be sought from throughout this state, to ensure that council 16 members live in different geographical areas of the state and that they reflect the 17tourism industry's diversity and its distribution throughout both urban and rural 18 areas of the state. Each council member, other than ex officio members, shall have experience in marketing and promotion strategy.". 19
