



**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 2,  
TO 1995 ASSEMBLY BILL 37**

February 16, 1995 – Offered by Representative KLUSMAN.

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 2, line 1: restore the stricken material.

3 **2.** Page 2, line 2: delete that line and substitute: “other than a ~~committee or~~  
4 an individual required to file an oath under s. 11.06 (7), who”.

5 **3.** Page 3, line 3: delete lines 3 and 4 and substitute:

6 “**SECTION 3e.** 11.06 (1) (j) of the statutes is amended to read:

7 11.06 (1) (j) In the case of a ~~committee or~~ an individual filing an oath under sub.  
8 (7), a separate schedule showing for each disbursement which is made independently  
9 of a candidate, other than a contribution made to that candidate, the name of the  
10 candidate or candidates on whose behalf or in opposition to whom the disbursement  
11 is made, indicating whether the purpose is support or opposition.

12 **SECTION 3m.** 11.06 (7) of the statutes is amended to read:

1           11.06 (7) OATH FOR INDEPENDENT DISBURSEMENTS. (a) Every ~~committee, other~~  
2 ~~than a personal campaign committee, which and every~~ individual, other than a  
3 candidate, who desires to make disbursements during any calendar year, which are  
4 to be used to advocate the election or defeat of any clearly identified candidate or  
5 candidates in any election shall, before making any disbursement, except within the  
6 amount authorized under s. 11.05 (1) or (2), file with ~~the~~ his or her registration  
7 statement under s. 11.05 a statement under oath affirming that the ~~committee or~~  
8 individual does not act in cooperation or consultation with any candidate or agent  
9 or authorized committee of a candidate who is supported, that the ~~committee or~~  
10 individual does not act in concert with, or at the request or suggestion of, any  
11 candidate or any agent or authorized committee of a candidate who is supported, that  
12 the ~~committee or~~ individual does not act in cooperation or consultation with any  
13 candidate or agent or authorized committee of a candidate who benefits from a  
14 disbursement made in opposition to a candidate, and that the ~~committee or~~  
15 individual does not act in concert with, or at the request or suggestion of, any  
16 candidate or agent or authorized committee of a candidate who benefits from a  
17 disbursement made in opposition to a candidate. ~~A committee which or~~ An  
18 individual who acts independently of one or more candidates or agents or authorized  
19 committees of candidates and also in cooperation or upon consultation with, in  
20 concert with, or at the request or suggestion of one or more candidates or agents or  
21 authorized committees of candidates shall indicate in the oath the names of the  
22 candidate or candidates to which it applies.

23           (b) ~~A committee or~~ An individual required to file an oath under this subsection  
24 shall file the oath at the time of registration under s. 11.05 or the time the ~~committee~~  
25 ~~or~~ individual becomes subject to this subsection, whichever is later. The ~~committee~~

1 or individual shall file an amendment to the oath whenever there is a change in the  
2 candidate or candidates to whom it applies. ~~A committee or~~ An individual shall refile  
3 the oath for each calendar year in which the ~~committee or~~ individual proposes to  
4 make disbursements specified in this subsection, no later than January 31 of that  
5 calendar year.

6 (c) Any individual who ~~or committee which~~ falsely makes an oath under par.  
7 (a), or any individual, ~~committee~~ or agent of an individual ~~or committee~~ who or which  
8 carries on any activities with intent to violate an oath under par. (a) is guilty of a  
9 violation of this chapter.

10 **SECTION 3s.** 11.06 (7m) of the statutes is repealed.”.”.

11 **4.** Page 3, line 6: delete lines 6 to 12.

12 **5.** Page 3, line 13: delete that line and substitute:

13 ““**SECTION 4r.** 11.12 (1) (a) of the statutes is amended to read:”.

14 **6.** Page 3, line 18: in lines 18 and 19, delete the stricken material and  
15 substitute: “, or by or through an individual ~~or committee~~ registered under s. 11.05  
16 and filing a statement under s. 11.06 (7)”.

17 **7.** Page 3, line 20: delete the material beginning with that line and ending with  
18 page 4, line 7, and substitute a quotation mark and period.

19 **8.** Page 4, line 12: in lines 12 and 13, delete the stricken material and  
20 substitute: “other than an individual who, ~~or a committee which~~, has registered  
21 under s. 11.05 and filed an oath under s. 11.06 (7),”.

22 **9.** Page 4, line 20: in lines 20 to 22, delete the stricken material and substitute:  
23 “This paragraph does not apply to an individual ~~or committee~~ filing an oath under  
24 s. 11.06 (7) with respect to the candidate who is supported or opposed.”.

1           **10.** Page 5, line 7: delete lines 7 and 8 and substitute:

2           “**SECTION 6c.** 11.21 (9) of the statutes is amended to read:

3           11.21 (9) Place a copy of any separate schedule under s. 11.06 (1) (j) received  
4 with the financial report of an individual ~~or committee~~ filing an oath under s. 11.06  
5 (7) in the file of each candidate to whom it relates.

6           **SECTION 6g.** 11.22 (10) of the statutes is amended to read:

7           11.22 (10) Place a copy of any separate schedule under s. 11.06 (1) (j) received  
8 with the financial report of an individual ~~or committee~~ filing an oath under s. 11.06  
9 (7) in the file of each candidate to whom it relates.”.

10          **11.** Page 5, line 10: delete “individual, other than a candidate, and no”.

11          **12.** Page 5, line 11: substitute “disbursements” for “expenditures”.

12          **13.** Page 5, line 15: in lines 15 to 17, delete the stricken material and  
13 substitute: “and to any individual ~~or committee~~ under s. 11.06 (7) acting solely in  
14 support of such a candidate or solely in opposition to the candidate’s opponent”.

15          **14.** Page 5, line 22: in lines 22 and 23, delete the stricken material and  
16 substitute: “and to any individual ~~or committee~~ under s. 11.06 (7) acting solely in  
17 support of such a candidate or solely in opposition to the candidate’s opponent”.

18          **15.** Page 6, line 1: delete the stricken material.

19          **16.** Page 6, line 4: delete that line and substitute:

20          “**SECTION 12m.** 11.30 (2) (d) of the statutes is amended to read:

21          11.30 (2) (d) In addition to the requirements of pars. (a) to (c), ~~a committee or~~  
22 an individual required to file an oath under s. 11.06 (7) shall also in every  
23 communication in support of or in opposition to any clearly identified candidate or

1 candidates include the words “Not authorized by any candidate or candidate’s agent  
2 or committee”.”.”.

3 **17.** Page 6, line 5: delete lines 5 to 13.
