



**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 1995 ASSEMBLY BILL 575**

January 9, 1996 – Offered by Representatives JOHNSRUD and BOYLE.

1 **AN ACT to amend** 23.09 (2) (d) 1.; and **to repeal and recreate** 28.04 of the
2 statutes; **relating to:** the management of state forests.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 23.09 (2) (d) 1. of the statutes is amended to read:

4 23.09 (2) (d) 1. For state forests ~~for the purpose of growing timber,~~
5 ~~demonstrating forestry methods, protecting watersheds or providing public~~
6 ~~recreation.~~

7 **SECTION 2.** 28.04 of the statutes is repealed and recreated to read:

8 **28.04 Management of state forests. (1) DEFINITIONS.** In this section:

9 (a) “Biological diversity” means the variety and abundance of species, their
10 genetic composition, and the communities, ecosystems and landscapes in which they
11 occur. “Biological diversity” also refers to the variety of ecological structures,
12 functions and processes at any of these levels.

13 (b) “Community” means an assemblage of species living together in a particular
14 area, time and habitat.

1 (c) “Ecological capability” means the potential of an area to support or develop
2 one or more communities through management, with the potential being dependent
3 on the area’s abiotic attributes, its flora and fauna, its ecological processes and
4 disturbances within and upon the area.

5 (d) “Native” means indigenous to the area or region.

6 (e) “Sustainable forestry” means the practice of managing dynamic forest
7 ecosystems to provide ecological, economic, social and cultural benefits for present
8 and future generations.

9 **(2) PURPOSES AND BENEFITS OF STATE FORESTS.** (a) The department shall manage
10 the state forests to benefit the present and future generations of residents of this
11 state, recognizing that the state forests contribute to local and statewide economies
12 and to a healthy natural environment. The department shall assure the practice of
13 sustainable forestry and use it to assure that state forests can provide a full range
14 of benefits for present and future generations. The department shall also assure
15 that the management of state forests is consistent with the ecological capability of
16 the state forest land and with the long-term maintenance of sustainable forest
17 communities and ecosystems. These benefits include soil protection, public hunting,
18 protection of water quality, production of recurring forest products, outdoor
19 recreation, native biological diversity, aquatic and terrestrial wildlife, and
20 aesthetics. The range of benefits provided by the department in each state forest
21 shall reflect its unique character and position in the regional landscape.

22 (b) In managing the state forests, the department shall recognize that not all
23 benefits under par. (a) can or should be provided in every area of a state forest.

24 (c) In managing the state forests, the department shall recognize that
25 management may consist of both active and passive techniques.

1 **(3) STATE FOREST PLANS.** (a) The department shall prepare a plan for each state
2 forest that describes how the state forest will be managed. The department shall
3 work with the public to identify property goals and objectives that are consistent with
4 the purposes under sub. (2). The department shall identify in each plan the
5 objectives of management for distinct areas of the state forest.

6 (b) The department shall establish procedures for the preparation and
7 modification of these plans, including procedures for public participation. In
8 preparing and modifying plans under this subsection, the department shall use the
9 best available information regarding the purposes and benefits of the state forests
10 that the department acquires through inventories, evaluations, monitoring and
11 research. In evaluating such information, the department shall consider both
12 regional and local scales, including the impact on local economies. As new
13 information becomes available, the department shall adapt its management of the
14 state forest and, if necessary, the plan for the state forest.

15 **SECTION 3. Cross-reference changes.** In the sections of the statutes listed
16 in Column A, the cross-references shown in Column B are changed to the
