6	3. Page 74, line 15: after "agency" insert: ", or, if as of December 1, 1995, the
7	individual was participating in education or training under s. $49.193\left(4\right)\left(j\right)4.$ or 49.27
8	(5) (e) 2., as part of a plan to complete that education or training program".
9	4. Page 75, line 1: delete lines 1 to 5 and substitute:
10	"(as) Required hours. A Wisconsin works agency may require a participant
11	placed in a community service job program to work not more than 40 hours per week
12	in a community service job. The Wisconsin works agency shall count the hours of
13	participation in education or training activities under par. (am) towards the
14	participation requirement.".
