4	SECTION 1. 814.04 (intro.) of the statutes is amended to read:
5	814.04 Items of costs. (intro.) Except as provided in ss. 93.20, 101.22 (6) (i)
6	and $(6m)$ (a), 769.313 , 814.025 , 814.245 , 895.035 (4), 895.75 (3), 895.77 (2), 895.79 (3),
7	943.212 (2) (b), 943.245 (2) (d) and 943.51 (2) (b), when allowed costs shall be as

9	Section 2. 895.79 of the statutes is created to read:
10	895.79 Damage to certain machines. (1) An owner of a machine operated
11	by the insertion of coins, currency, debit cards or credit cards that is damaged by a
12	person acting with the intent to commit a theft from that machine may bring an
13	action against the person.

1 (2) The owner has the burden of proving his or her case under sub. (1) by a 2 preponderance of the credible evidence. 3 (3) If the owner prevails in a civil action under sub. (1), he or she may recover 4 all of the following: 5 (a) Treble damages. 6 Costs, including all reasonable attorney fees and other costs of the 7 investigation and litigation that were reasonably incurred. 8 (4) An owner may bring a civil action under sub. (1) regardless of whether there 9 has been a criminal action related to the damage under sub. (1) and regardless of the 10 outcome of any such criminal action. 11 **Section 3.** 943.01 (2g) of the statutes is created to read: Any person violating sub. (1) under all of the following 12 943.01 (**2g**) 13 circumstances is guilty of a Class E felony: 14 (a) The property damaged is a machine operated by the insertion of coins, 15 currency, debit cards or credit cards. (b) The person acted with the intent to commit a theft from the machine. 16 17 (c) The total property damaged in violation of sub. (1) is reduced in value by more than \$500 but not more than \$1,000. For purposes of this paragraph, property 18 19 is reduced in value by the amount that it would cost to repair or replace it, whichever 20 is less, plus other monetary losses associated with the damage. 21 **Section 4.** 946.82 (4) of the statutes is amended to read: 22 946.82 (4) "Racketeering activity" means any activity specified in 18 USC 1961 23 (1) in effect as of April 27, 1982 or the attempt, conspiracy to commit, or commission 24 of any of the felonies specified in: chs. 161 and 945 and ss. 49.49, 134.05, 139.44 (1), 25180.0129, 181.69, 184.09 (2), 185.825, 215.12, 221.17, 221.31, 221.39, 221.40, 551.41,
