7 and family services; changing references to low-income and at-risk child care
8 funding; the use of relief block grant funds by tribal governing bodies;
9 administration of Wisconsin works in counties having a population of 500,000
10 or more; state involvement with certain municipal boundary changes;
11 refunding of municipal bonds; a performance evaluation audit of the University
12 of Wisconsin Hospitals and Clinics Authority; the lease agreement and
13 affiliation agreement between the University of Wisconsin System and the
14 University of Wisconsin Hospitals and Clinics Authority; the contractual
15 services agreement between the University of Wisconsin Hospitals and Clinics
16 Board and the University of Wisconsin Hospitals and Clinics Authority;
17 accumulated sick leave credits for the purchase of health insurance under the
18 Wisconsin retirement system; making certain employees at the University of
19 Wisconsin Hospitals and Clinics Authority eligible for health insurance
20 coverage under a plan offered by the group insurance board and requiring the
21 group insurance board to consult with the University of Wisconsin Hospitals
22 and Clinics Authority in the establishment of this plan; issuance of bonds by the
23 University of Wisconsin Hospitals and Clinics Authority; membership of the
24 University of Wisconsin Hospitals and Clinics Board and of the board of
25 directors of the University of Wisconsin Hospitals and Clinics Authority;

1 storage and management of records of the University of Wisconsin Hospitals
2 and Clinics Authority; applicability of municipal ordinances and regulations to
3 certain buildings, structures and facilities constructed for the benefit or use of
4 local professional baseball park districts; newly incorporated municipalities'
5 populations for shared revenue distributions; local transportation aids for
6 newly incorporated cities and villages; taxes levied by newly incorporated cities
7 and villages; changing the name of the Kickapoo valley governing board; the
8 effective date and initial applicability of adjustments in certain lobbying
9 regulation fees; railroad stockholder reports; bonding authorizations for the
10 department of health and social services; funding and authorized full-time
11 equivalent positions for the land information board; funding, powers and duties
12 of the Wisconsin sesquicentennial commission; prevailing hours of labor for
13 workers employed on state or local public works projects; granting bonding
14 authority; granting rule-making authority; and making and decreasing
15 appropriations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

16 **SECTION 1g.** 13.094 of the statutes is created to read:

17 **13.094 Review of University of Wisconsin Hospitals and Clinics**
18 **Authority lease and affiliation agreements.** (1) FIVE-YEAR REVIEW. By June 29,
19 2001, and every 5 years thereafter by June 29, the joint committee on finance shall
20 review the lease agreement under s. 233.04 (7) or (7g) and the affiliation agreement
21 under s. 233.04 (7m) or (7p). If the joint committee on finance determines that either
22 the lease agreement or the affiliation agreement, or both, should be terminated, the
23 committee shall submit its recommendations regarding the agreements to the

1 legislature under s. 13.172 (2). The committee's recommendations shall include any
2 suggested legislation necessary to adequately provide for the protection of the
3 bondholders and those entering into contracts with the authority or to modify the
4 powers and duties of the University of Wisconsin Hospitals and Clinics Authority to
5 reflect termination of the lease agreement or affiliation agreement, or both.

6 **(2) TERMINATION OF AGREEMENTS.** If the joint committee on finance determines
7 that legislation has been enacted to adequately provide for the protection of the
8 bondholders and those entering into contracts with the authority or to modify the
9 powers and duties of the University of Wisconsin Hospitals and Clinics Authority to
10 reflect termination of the lease agreement or affiliation agreement, or both, or if the
11 committee determines that no such legislation is necessary, the committee may
12 terminate the lease agreement or affiliation agreement, or both.

13 **(3) RECOMMENDED LEGISLATION.** If the lease agreement under s. 233.04 (7) or
14 (7g) or the affiliation agreement under s. 233.04 (7m) or (7p) ceases to be in effect for
15 a reason other than termination under sub. (2), the joint committee on finance shall
16 recommend any legislation that it considers appropriate or desirable in light of the
17 lease agreement or affiliation agreement ceasing to be in effect, including adequate
18 provision for the protection of the bondholders of the University of Wisconsin
19 Hospitals and Clinics Authority and those entering into contracts with the authority.
20 The joint committee on finance shall submit its recommendations to the legislature
21 under s. 13.172 (2).
