## ASSEMBLY AMENDMENT 6, TO SENATE SUBSTITUTE AMENDMENT 1, TO 1997 ASSEMBLY BILL 351

May 5, 1998 - Offered by Representatives BALDWIN, ROBSON, KRUG and R. YOUNG.

1	At the locations indicated, amend the substitute amendment as follows:
2	<b>1.</b> Page 9, line 16: after that line insert:
3	"SECTION 16g. 20.433 (1) (c) of the statutes is created to read:
4	20.433 (1) (c) Child abuse and neglect prevention grants. A sum sufficient equal
5	to $0.5\%$ of the total amounts appropriated and estimated to be expended from all
6	sources for the department of corrections for each fiscal year as shown in the schedule
7	under s. 20.005 (3), to be used for grants to organizations under s. 48.982 (4), (6) and
8	(7) and for statewide projects under s. 48.982 (5). The child abuse and neglect
9	prevention board may not encumber or expend more than \$1,749,700 from this
10	appropriation between January 1, 1999, and June 30, 1999.
11	<b>SECTION 16h.</b> 20.433 (1) (c) of the statutes, as created by 1997 Wisconsin Act
12	(this act), is amended to read:

1	20.433 (1) (c) Child abuse and neglect prevention grants. A sum sufficient equal
2	to $0.5\%$ of the total amounts appropriated and estimated to be expended from all

5	(7) and for statewide projects under s. 48.982 (5). The child abuse and neglect
6	prevention board may not encumber or expend more than \$1,749,700 from this
7	appropriation between January 1, 1999, and June 30, 1999.
8	<b>SECTION 16r.</b> 20.435 (3) (b) of the statutes is created to read:
9	20.435 (3) (b) Child abuse and neglect prevention grants and projects. A sum
10	sufficient equal to $0.5\%$ of the total amounts appropriated and estimated to be
11	expended from all sources for the department of corrections for each fiscal year as
12	shown in the schedule under s. 20.005 (3), to be used for grants to programs and
13	statewide projects the primary goal of which is the prevention of child abuse and
14	neglect. The department of health and family services may not encumber or expend
15	more than \$1,749,700 from this appropriation between January 1, 1999, and June
16	30, 1999.
17	<b>SECTION 16s.</b> 20.435 (3) (b) of the statutes, as created by 1997 Wisconsin Act
18	(this act), is amended to read:
19	20.435 (3) (b) Child abuse and neglect prevention grants and projects. A sum
20	sufficient equal to $0.5\%$ of the total amounts appropriated and estimated to be
21	expended from all sources for the department of corrections for each fiscal year as

shown in the schedule under s. 20.005 (3), to be used for grants to programs and
statewide projects the primary goal of which is the prevention of child abuse and
neglect. The department of health and family services may not encumber or expend

more than \$1,749,700 from this appropriation between January 1, 1999, and June

The plan shall ensure that funds from the appropriation account 8 under s. 20.435 (3) (b) are not used to supplant any other funding the department 9 provides for the prevention of child abuse and neglect. Beginning in 1999, by June 10 30 of each year the department shall submit a copy of the plan for the next fiscal year 11 to the chief clerk of each house of the legislature, for distribution to the appropriate 12standing committees under s. 13.172 (3).". **3.** Page 13. line 14: after that line insert: 13 14 "SECTION 34e. 48.982 (4) (a) of the statutes is amended to read: 1548.982 (4) (a) From the appropriations under s. 20.433 (1) (c), (h), (i), (k), (m) 16 and (q), the board shall award grants to organizations in accordance with the plan 17developed under sub. (2) (a). In each of the first 2 fiscal years in which grants are 18 awarded, no organization may receive a grant or grants totaling more than \$15,000. 19 **SECTION 34f.** 48.982 (5) of the statutes is amended to read: 20 48.982 (5) STATEWIDE PROJECTS. From the appropriations under s. 20.433 (1) (c), 21(i) and (r), the board shall administer any statewide project for which it has accepted 22money under sub. (2m) (c). 23**SECTION 34g.** 48.982 (6) (a) of the statutes is amended to read:

4	receive a grant or grants under this subsection totaling more than \$75,000 in any
5	year.
6	<b>SECTION 34h.</b> 48.982 (7) (a) of the statutes is amended to read:
7	48.982 (7) (a) From the appropriations under s. 20.433 (1) $(\underline{c})$ , (h), (i), (k) and
8	(q), the board shall award grants to organizations in accordance with the plan
9	developed under sub. (2) (a).".
10	<b>4.</b> Page 44, line 23: delete the material beginning with that line and ending
11	with page 45, line 2.
12	<b>5.</b> Page 140, line 17: before that line insert:
13	"(2f) Child Abuse and neglect prevention funding. Notwithstanding section
14	$20.002\ (1)$ of the statutes, if the biennial budget act for the biennium beginning July
15	1, 1999, is not enacted on or before June 30, 1999, moneys encumbered or expended
16	from the appropriation accounts under sections 20.433 (1) (c) and 20.435 (3) (b) of the
17	statutes, as amended by this act, may not exceed, for each month beginning July 1,
18	1999, until enactment of the biennial budget, an amount equal to one-sixth the
19	amount of the money that was authorized to be encumbered and expended from the
20	appropriation accounts from January 1, 1999, to June 30, 1999.".
21	<b>6.</b> Page 142, line 23: after that line insert:
22	"(1f) Child abuse and neglect prevention funding.
23	(a) The creation of sections $20.433(1)(c)$ and $20.435(3)(b)$ of the statutes takes
24	effect on January 1, 1999.
